

ORDINANCE NO. 05-11-1

AN ORDINANCE ANNEXING ALL OR A PART OF CERTAIN LANDS
ADJACENT TO THE CITY OF EUFAULA

1. WHEREAS, there are certain lands that are adjacent to the City of Eufaula, Oklahoma and the City Council deems it necessary to increase the City Limits to include certain lands within the corporate limit of said City of Eufaula, Oklahoma:
2. AND, WHEREAS, under the laws of the State of Oklahoma, the City Council has the right, to add such territory adjacent to the City Limits as it may deem proper:
3. AND, WHEREAS, the property hereinafter described, is property that may be added to the City of Eufaula, Oklahoma, under the existing provisions of the laws of the State of Oklahoma, to wit:

A parcel of land in the SW/4 of Section 26, Township 10 North, Range 16 East of the I.B.M., McIntosh County, Oklahoma said parcel being a part of Eufaula Lake Tract O-1569-1 and more particularly described as:

Commencing at the Southwest corner of said Section 26; thence due East 94.73 feet; thence on a curve to the right having a radius of 639.35 feet and a length of 106.67 feet to the Point of Beginning;
thence on a curve to the right having a radius of 639.35 feet and a distance of 392.62 feet;
thence North 71 degrees 21 minutes 52 seconds East a distance of 419.44 feet; thence on a curve to the left having a radius of 577.65 feet and a distance of 314.43 feet; thence North 40 degrees 10 minutes 35 seconds East a distance of 225.81 feet; thence on a curve to the right having a radius of 1098.94 feet and a distance of 448.29 feet; thence South 65 degrees 00 minutes 38 seconds West a distance of 607.79 feet; thence on a curve to the right having a radius of 748.48 feet and a distance of 331.01 feet; thence South 89 degrees 39 minutes 03 seconds East a distance of 301.90 feet; thence South 84 degrees 22 minute 27 seconds West a distance of 192.79 feet; more or less to the Point of Beginning.

That it is necessary to include said area as a part of the corporate limits of the City of Eufaula, Oklahoma.

BE IT THEREFORE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF EUFAULA, MCINTOSH COUNTY, that the property hereinabove described be and the same is hereby annexed to and incorporated in the corporate city limits of the City of Eufaula, Oklahoma, from the date of passage and approval of this ordinance as provided by law.


That this annexation is under the regulations and restrictions of Title 11, Section 21-103 of the laws of the State of Oklahoma.




