


ORDINANCE NO. 13-9-3



AN ORDINANCE ANNEXING the following legally described property: A tract of land situated in the W1/2 of Section 26, T-10-N, R-16-E, of the I.B.M., McIntosh County, State of Oklahoma, better described as follows: Beginning at the SW corner of said W1/2; thence N00°07'10"E along the West line of said W1/2 a distance of 1615.67 feet to the True Point of Beginning; thence continuing N00°07'10"E along said West line a distance of 1084.30 feet; thence N90°00'00"E a distance of 294.38 feet; thence N50°17'24"E a distance of 395.37 feet; thence S06°38'30"W a distance of 300.00 feet; thence S28°33'10"W a distance of 108.93 feet; thence S28°35'00"W a distance of 606.98 feet; thence S28°35'44"W a distance of 467.23 feet to the True Point of Beginning. Said tract contains 8.11 acres, more or less. **FINDING THE CONSENT OF THE OWNER OF THE ACREAGE INVOLVED; FINDING THE BASIS FOR ANNEXATION ADEQUATE AND NECESSARY FOR MUNICIPAL PURPOSES; FINDING THAT THE CITY HAS CONDUCTED A PUBLIC HEARING AND GIVEN NOTICE IN ACCORDANCE WITH APPLICABLE LAW; AND DECLARING AN EMERGENCY.**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF EUFAULA:

SECTION 1. The City Council finds and declares that the following tract of land is adjacent and contiguous with the city limits of the City of Eufaula. The land is appropriate land for annexation and that the city has the actual consent of the owner of the acreage within this territory. Therefore, under Title 11 O.S. § 21-103 A, the territory can be annexed by the action of the City Council. Having mailed and published required notices as required by law, having conducted a public hearing on September 9, 2013 and having already provided utility service and other plans for the area, the Council finds that the legal requirements are met and it desires to complete the annexation of this territory.

SECTION 2. 
SECTION 3 The service plan and schedule is to be effective immediately, inasmuch that services have already been provided.
