AN ORDINANCE ANNEXING ALL OR A PART OF CERTAIN LANDS
ADJACENT TO THE CITY OF EUFAULA

1. WHEREAS, there are certain lands that are adjacent to the City of Eufaula, Oklahoma and the City Council deems it necessary to increase the City Limits to include certain lands within the corporate limit of said City of Eufaula, Oklahoma;

2. AND, WHEREAS, under the laws of the State of Oklahoma, the City Council has the right, to add such territory adjacent to the City Limits as it may deem proper, provided that in no case shall any additional territory except when subdivided into tracts or parcels of less than five (5) acres with more than one residence thereon be added to the City Limits without the consent of a majority of the whole number of acres owned by such residents except where same is bounded on three sides by the City of Eufaula, Oklahoma.

3. AND, WHEREAS, the property hereinafter described, is property that may be added to the City of Eufaula, Oklahoma, under the existing provisions of the laws of the State of Oklahoma, to-wit:

The N $\frac{1}{2}$ of Section 3 and the N $\frac{1}{2}$ of Section 4 of Township 9 North, Range 16 East; and, the S $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 34, Township 10 North, Range 16 East, McIntosh County, Oklahoma


That it is necessary to include said area as a part of the corporate limits of the City of Eufaula, Oklahoma.

BE IS THEREFORE RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF EUFAULA, MCINTOSH COUNTY, that the property hereinabove described be and the same is hereby annexed to and incorporated in the corporate city limits of the City of Eufaula, Oklahoma, from the date of passage and approval of this ordinance as provided by law.

That this annexation is under the regulations and restrictions of Title II, Sections 481 through 490 of the laws of the State of Oklahoma.

That it being necessary for the preservation of public peace, health and safety, an emergency is hereby declared to exist and said ordinance shall be in full force and effect after its passage, approval and publication.
