

WHEREAS, by Ordinance No. 84-6-1, the City Council of the City of Eufaula, Oklahoma, annexed certain properties into the City of Eufaula, Oklahoma, and;

WHEREAS, subsequent to that date, it has been determined that there were certain irregularities as to certain portions of the lands annexed, and;

WHEREAS, it is the desire of the City of Eufaula, Oklahoma, do de-annex and remove certain portions of the lands so annexed from the City of Eufaula, Oklahoma:

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF EUFAULA, OKLAHOMA, that insofar as Ordinance No. 84-5-1, annexed the following described property, towit:

TRACT NO. 1: Lot 2 (NW $\frac{1}{2}$  NE $\frac{1}{2}$ ), Lot 3 (NE $\frac{1}{2}$  NW $\frac{1}{2}$ ) and SE $\frac{1}{2}$  NW $\frac{1}{2}$  of Section 3, Township 9 North, Range 16 East, McIntosh County, Oklahoma, LESS & EXCEPT the following described tract, towit:

A part of Lot 3 of Sec. 3, Twp. 9N, Rge. 16 East, particularly described as follows, towit: Beg. at a point which is 630 feet East of the Northwest Corner of said Lot 3; thence South 528.80'; thence East 420'; thence North 103.8'; thence West 210'; thence North 167.57'; thence East 210'; thence North 257.42'; thence West 420' to the point of beginning;

TRACT NO. 2: Lot 1 (NE $\frac{1}{2}$  NE $\frac{1}{2}$ ) and Lot 2 (NW $\frac{1}{2}$  NE $\frac{1}{2}$ ) and S $\frac{1}{2}$  NE $\frac{1}{2}$  of Section 4, Township 9 North, Range 16 East, LESS & EXCEPT the following tracts, towit:

(a) A tract of land located in said Lot 1, more particularly described as follows, towit: Beg. at a point on the East line of said Lot 1, said point being 50.00' South of the NE corner of said Lot 1; thence South along said East line a distance of 500.0' to a point; thence Southwesterly on a straight line a distance of 76.16' to a point, said point being 580.00' South and 70.00' West of the NE corner of said Lot 1; thence Northwesterly on a straight line a distance of 957.35' to a point, said point being 915.00' west and 130.00' South of the NE Corner of said Lot 1; thence Northeasterly on a straight line a distance of 276.81' to a point; said point being 650.0' West and 50' South of the NE corner of said Lot 1; thence East parallel to the North line of said Lot 1 a distance of 650.0' to the point of beginning, said tract contains 6.5 acres, m/l;

and

(b) The West 164 feet of Lot 2 of Section 4, Township 9 North, Range 16 East, All in McIntosh County, Oklahoma;

to the City of Eufaula, Oklahoma, the same is hereby vacated. In all other respects, said Ordinance No. 84-6-1, shall remain in full force and effect.

That it being necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, and said ordinance shall be in full force and effect after its passage, approval, and publication.


PASSED AND APPROVED this 1st day of October, 1984, and the Emergency Clause voted on separately and passed.
