

ORDINANCE NO. 2011-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE TOWN OF FOSTER, OKLAHOMA, TO INCLUDE AND INCORPORATE WITHIN SAID AND ANNEX TO SAID TOWN A TRACT OF LAND ADJACENT TO THE CURRENT TOWN LIMITS OF THE TOWN OF FOSTER, OKLAHOMA

WHEREAS, it has been deemed advisable by the Town to extend the corporate limits and boundaries of the Town of Foster, Oklahoma, to include a certain area adjacent to the town limits of the Town of Foster, Oklahoma more particularly described below;

WHEREAS, the owners of the real property described below has consented to such annexation, as evidenced by said owner's consent attached hereto;

NOW, THEREFORE,

BE IT ORDAINED BY THE Town of Foster, OKLAHOMA:

Section 1: That the incorporated limits of the Foster, Oklahoma be extended to include the following described tracts of land located in Garvin County, Oklahoma:

Tract 1 (John Ferris):

Surface and Surface estate only in and to the N/2 NW/4 & the N/2 NE/4 & NW/4 SW/4 NE/4 of Section 30, Township 2 North, Range 2 West, in Garvin County, State of Oklahoma, Containing 170 acres, less 6.61 acres for highway, leaving 163.39 acres, more or less.

AND

Tract 2 (Thomas Gilmore):

The SW/4 of the SW/4 of the SW/4 of Section 20, Township 2 North, Range 2 West of the I.M., Garvin County, Oklahoma; LESS AND EXCEPT all oil, gas and other minerals.

Section 2: It being immediately necessary for the preservation of the public peace, public health, public safety and morals, an emergency is hereby declared to exist, and the within Ordinance shall become effective immediately upon its passage and approval.
