

ORDINANCE NO. 2002-4

AN ORDINANCE FOR THE CITY OF GEARY, OKLAHOMA, ANNEXING THAT PORTION OF U.S. HIGHWAY 66 FROM THE INTERSECTION WITH U.S. HIGHWAY 281 EXTENDING EAST FOR ONE (1) MILE and THAT PORTION OF THE I40 NORTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING EAST FOR ONE-HALF (1/2) MILE and THAT PORTION OF THE I40 SOUTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING EAST FOR ONE-HALF (1/2) MILE and THAT PORTION OF THE I40 NORTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING WEST FOR ONE-HALF (1/2) MILE and THAT PORTION OF THE I40 SOUTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING WEST FOR (1/2) MILE and THAT PORTION OF THE FRONTAGE ROAD SOUTH OF I40 EXTENDING ONE (1) MILE WEST OF U.S. HIGHWAY 281; DECLARING REPEALER, DECLARING SEVERABILITY, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF GEARY, OKLAHOMA:

SECTION 1. That the City Council has determined that The Oklahoma Department of Transportation has given its consent for the City of Geary to annex the following property and that the property is adjacent to the City of Geary:

THAT PORTION OF U.S. HIGHWAY 66 FROM THE INTERSECTION WITH U.S. HIGHWAY 281 EXTENDING EAST FOR ONE (1) MILE and
THAT PORTION OF THE I40 NORTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING EAST FOR ONE-HALF (1/2) MILE and
THAT PORTION OF THE I40 SOUTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING EAST FOR ONE-HALF (1/2) MILE and
THAT PORTION OF THE I40 NORTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING WEST FOR ONE-HALF (1/2) MILE and
THAT PORTION OF THE I40 SOUTH EXIT RAMP EXIT NO. 108 AT U.S. HIGHWAY 281 EXTENDING WEST FOR (1/2) MILE and
THAT PORTION OF THE FRONTAGE ROAD SOUTH OF I40 EXTENDING ONE (1) MILE WEST OF U.S. HIGHWAY 281

The letter of consent is on file in the city office. Pursuant to 11 O.S. § 21-101 *et. sec.* the above described roads, entrance ramps and rights of way are hereby annexed into the city limits of the City of Geary. Attached is a map of the annexed property.

SECTION 2. Repealer. All former ordinances or parts of Ordinances conflicting or inconsistent with the provisions of this are hereby repealed.


SECTION 3. Severability. If any section, subsection, sentence, clause, phrase or portion of


