

ORDINANCE NO. 2003-1

AN ORDINANCE FOR THE CITY OF GEARY, OKLAHOMA, ANNEXING THE PROPERTY, WITH THE CONSENT OF THE OWNERS OF A MAJORITY OF THE ACRES TO BE ANNEXED, CONSISTING OF A STRIP OF LAND EXTENDING 400 FEET FROM THE HIGHWAY RIGHT OF WAY ON EACH SIDE OF U.S. HIGHWAY 281 SPUR FROM THE MAIN PORTION OF THE CITY OF GEARY IN BLAINE COUNTY AND EXTENDING TO THE CITY LIMITS AT THE US HIGHWAY 281 SPUR INTERCHANGE AT 140 IN CANADIAN COUNTY, EXCLUDING THAT PORTION ON THE NORTH SIDE OF THE 281 SPUR IN THE N.W. 1/4 OF SECTION 4, TOWNSHIP 12 NORTH RANGE 10 WEST OF THE INDIAN MERIDIAN; DECLARING REPEALER, DECLARING SEVERABILITY, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF GEARY, OKLAHOMA:

SECTION 1. That the City Council has determined that the written consent of the owners of at least a majority of the acres of the area to be annexed has been obtained pursuant to 11 O.S. § 21-101 *et. sec.* and is on file in the city office and that the property is adjacent to the City of Geary and therefore the property described on the attached Exhibit A is hereby annexed into the corporate limits of the City of Geary. Also attached as Exhibit B is a map showing the annexed property.

SECTION 2. Repealer. All former ordinances or parts of Ordinances conflicting or inconsistent with the provisions of this are hereby repealed.

SECTION 3. Severability. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, said portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

SECTION 4. Emergency. It being immediately necessary for the preservation of the public health, peace and safety of the City of Geary and the inhabitants thereof, an emergency is hereby declared to exist by reason whereof, this Ordinance shall be in full force and effect from and after its passage and approval, as provided by law.





