

ORDINANCE NO. 651

AN ORDINANCE ANNEXING CERTAIN REAL PROPERTY INTO THE CITY OF GLENPOOL, OKLAHOMA, MUNICIPAL LIMITS; AND DECLARING AN EMERGENCY

WHEREAS, the owners of certain real property have requested of the City of Glenpool, Oklahoma, that such real property be annexed into the City of Glenpool, Oklahoma; and,

WHEREAS, the City Council has considered and determined that it is in the best interest of the City of Glenpool, Oklahoma, to accept and act upon the petitioners' request for incorporation into the municipal limits; and,

WHEREAS, such annexation is pursuant to the City Ordinances of the City of Glenpool, Oklahoma, and further pursuant to Statutes of the State of Oklahoma.

BE IT THEREFORE ORDAINED by the City Council of the City of Glenpool, Oklahoma:

1. That the following described real property shall be and hereby is annexed to the City of Glenpool:

2. That such annexed real property shall be included within the boundaries of City Ward No. 2 as depicted on the map entitled "Glenpool City Council Wards – Plan 1," as based on 2010 U.S. Census results and as adopted by the City Council at its Regular Meeting on September 19, 2011.
3. That all ordinances or parts of ordinances in conflict herewith shall be and hereby are repealed and of no effect.






