

ORDINANCE 2004-13

AN ORDINANCE OF THE TOWN OF GOLDSBY, OKLAHOMA, EXTENDING THE CORPORATE LIMITS OF THE TOWN OF GOLDSBY, OKLAHOMA BY ANNEXING TERRITORY ADJACENT TO THE TOWN MORE FULLY DESCRIBED AS

A tract of land lying in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ and the N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 9, Township 7 North, Range 2 West, McClain County, Oklahoma, more particularly described as follows: Beginning at the SW Corner of the N $\frac{1}{2}$ SW $\frac{1}{4}$ of said Section 9, thence East 1,186.5 feet on the South line of said N $\frac{1}{2}$ SW $\frac{1}{4}$ of said Section 9, thence Northwesterly on a curve to the right having a radius of 43,071.9 feet a distance of 307.8 feet, thence N37°19'W a distance of 1,639.8 feet more or less to the West line of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 9, thence South along the West line of said Section 9 to the point of beginning



AND DECLARING AN EMERGENCY TO EXIST BY REASON WHEREOF THIS ORDINANCE IS TO BE IN FULL FORCE AND EFFECT IMMEDIATELY UPON ITS ADOPTION.

WHEREAS, a petition has been presented to the Board of Trustees of the Town of Goldsby, Oklahoma requesting the Town to annex the hereinbelow described property; and

WHEREAS, notice of the presentation of the Petition has been published once each week for two consecutive weeks, as by law required, in the Purcell Register, a newspaper of general circulation in the Town of Goldsby; and

WHEREAS, it appears that the statements of the petitioner and the petition are true and correct, that the petitioners constitute three-fourths or more of the registered voters and the owners of three-fourths or more in value of the property which is the subject of the petitioner's annexation request, that said property is adjacent or contiguous to the corporate limits of the Town of Goldsby, and that petitioner is requesting annexation of the property which is the subject of the petitioner's annexation request; and

WHEREAS, it appears that it is in the interest of the Town of Goldsby, Oklahoma and the citizens and residents thereof that the petition be granted and that the territory proposed to be annexed be annexed to the Town;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GOLDSBY, OKLAHOMA, THAT:

SECTION 1. ANNEXATION. The corporate limits of the Town of Goldsby, Oklahoma shall be and the same are hereby extended to include, add, and annex the following designated or described lands and territory:

A tract of land lying in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ and the N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 9, Township 7 North, Range 2 West, McClain County, Oklahoma, more particularly described as follows: Beginning at the SW Corner of the N $\frac{1}{2}$ SW $\frac{1}{4}$ of said Section 9, thence East 1,186.5 feet on the South line of said N $\frac{1}{2}$ SW $\frac{1}{4}$ of said Section 9, thence Northwesterly on a curve to

the right having a radius of 43,071.9 feet a distance of 307.8 feet, thence N37 ° 19'W a distance of 1,639.8 feet more or less to the West line of the SW¼ NW¼ of said Section 9, thence South along the West line of said Section 9 to the point of beginning

and all of said lands and territory shall be and the same are hereby included in, added to and annexed into said Town.

SECTION 2. EMERGENCY. It being necessary for the preservation of the public health, safety, peace and welfare of the citizens and residents of the Town of Goldsby, Oklahoma, that this Ordinance shall become effective immediately, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall take full force and effect immediately upon its adoption, as provided by law.
