


**TOWN OF GOLDSBY
ORDINANCE 2007- 3**



AN ORDINANCE OF THE TOWN OF GOLDSBY, OKLAHOMA, EXTENDING THE CORPORATE LIMITS OF THE TOWN OF GOLDSBY, OKLAHOMA BY ANNEXING TERRITORY ADJACENT TO THE TOWN MORE FULLY DESCRIBED AS FOLLOWS:

All portions of the E2 of Section 9, Township 8 North, Range 3 West, I.M., situated south of the south edge of the right-of-way of State Highway No. 9 in McClain County, Oklahoma;

All portions of Section 8, Township 8 North, Range 3 West, I.M., situated south of the south edge of the right-of-way of State Highway No. 9 in McClain County, Oklahoma, less and except all portions of said Section 8 included within the plat of Whippoorwill Estates recorded in Book 368, Page 435 of the records of the County Clerk of McClain County, Oklahoma;

The North 330 feet of the NE4 of Section 16, Township 8 North, Range 3 West and the E2 NW4 and N2 NE4 SW4 of said Section 16 and the North 330 feet of the NW4 NW4 of said Section 16;

N2 N2 N2 NE4 and W2 W2 NW4 NE4 of Section 17, Township 8 North, Range 3 West, I.M.; and NE4 NW4 of said Section 17 less and except all portions of said NE4 NW4 included within the plat of Whippoorwill Estates recorded in Book 368, page 435 of the records of the County Clerk of McClain County, Oklahoma; and the E2 E2 NW4 NW4 of said Section 17, Township 8 North, Range 3 West, I.M.; and

All portions of Section 7, Township 8 North, Range 3 West, I.M., situated south of the south edge of the right-of-way of State Highway No. 9 in McClain County, Oklahoma;

INCORPORATING THE SERVICE PLAN FOR THE PROVISION OF MUNICIPAL SERVICES TO THE ANNEXED TERRITORY; SETTING FORTH THE TIME PERIOD FOR COMPLETION OF IMPLEMENTATION OF THE SERVICE PLAN; AND DECLARING AN EMERGENCY TO EXIST BY REASON WHEREOF THIS ORDINANCE IS TO BE IN FULL FORCE AND EFFECT IMMEDIATELY UPON ITS ADOPTION.

WHEREAS, pursuant to the authority conferred upon the Town Board of Trustees by Section 21-104 of Title 11 of the Oklahoma Statutes, the Town Board of Trustees of Goldsby, Oklahoma proposed to annex, by governing body action, certain territory adjacent to the town which has not been platted; and

WHEREAS, in conformity with said statute, the Town Board of Trustees caused to be prepared a plan to extend appropriate town services to the territory to be annexed; and

WHEREAS, in conformity with said statute, the Town Board of Trustees on March 8, 2007 directed that notice of the proposed annexation of the territory be published in conformity with the requirements of said statute, and thereafter caused said notice to be published and mailed in conformity with the requirements of said statute.

WHEREAS, the notice gave notice of the proposed annexation; described the boundaries of the territory proposed to be annexed by legal description, reference to geographical location, and by map; gave notice that the service plan had been prepared and was available for inspection at the Goldsby Town Hall; and stated the date, time and place that the Town Board of Trustees would conduct a public hearing on the question of annexing the territory; and

WHEREAS, the Town Board of Trustees did conduct the public hearing on April 9, 2007 at 6:00 p.m. at the Goldsby Town Hall, that being date, time and place for hearing stated in the notice and being not earlier than 14 days nor later than 30 days following the publication and mailing of the notice; and

WHEREAS, at the public hearing the proposed service plan was available for inspection and was explained in conformity with the provisions of said statute; and

WHEREAS, the territory to be annexed has an assessed valuation smaller than the assessed valuation of the Town; and

WHEREAS, it appears that the territory to be annexed is adjacent to the Town, and that in planning the future growth and development of the Town, the Board of Trustees has determined that it is in the interest of the Town of Goldsby, Oklahoma and the citizens and residents thereof that the territory be annexed to the Town;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF GOLDSBY, OKLAHOMA, THAT:

SECTION 1. ANNEXATION. The corporate limits of the Town of Goldsby, Oklahoma shall be and the same are hereby extended to include the following designated or described lands and territory:

All portions of the E2 of Section 9, Township 8 North, Range 3 West, I.M., situated south of the south edge of the right-of-way of State Highway No. 9 in McClain County, Oklahoma;

All portions of Section 8, Township 8 North, Range 3 West, I.M., situated south of the south edge of the right-of-way of State Highway No. 9 in McClain County, Oklahoma, less and except all portions of said Section 8 included within the plat of Whippoorwill Estates recorded in Book 368, Page 435 of the records of the County Clerk of McClain County, Oklahoma;

The North 330 feet of the NE4 of Section 16, Township 8 North, Range 3 West and the E2 NW4 and N2 NE4 SW4 of said Section 16 and the North 330 feet of the NW4 NW4 of said Section 16;

N2 N2 N2 NE4 and W2 W2 NW4 NE4 of Section 17, Township 8 North, Range 3 West, I.M.; and NE4 NW4 of said Section 17 less and except all portions of said NE4 NW4 included within the plat of Whippoorwill Estates recorded in Book 368, page 435 of the records of the County Clerk of McClain County, Oklahoma; and the E2 E2 NW4 NW4 of said Section 17, Township 8 North, Range 3 West, I.M.; and

All portions of Section 7, Township 8 North, Range 3 West, I.M., situated south of the south edge of the right-of-way of State Highway No. 9 in McClain County, Oklahoma;

and all of said lands and territory shall be and the same are hereby annexed to said Town.


SECTION 2. INCORPORATION OF SERVICE PLAN. The final Service Plan to extend appropriate Town services to the annexed lands and territory, which is set forth in full in Resolution 2007-3 of the Town Board of Trustees and any amendment thereto adopted pursuant to negotiation at the public hearing, shall be and the same is hereby incorporated by reference into and made a part of this ordinance as though fully set forth verbatim.

SECTION 3. SERVICE PLAN IMPLEMENTATION. The time period, as determined at the public hearing, for completing the implementation of the Service Plan is: Municipal services and utilities of the kind uniformly provided by the municipality to all other areas of the Town of Goldsby, Oklahoma shall be made available to the annexed territory on like basis and cost as the same are made available to all other areas of the Town of Goldsby, Oklahoma, immediately upon, and from and after the annexation of the territory; provided that such services may be provided by any methods or means available to the Town of Goldsby, Oklahoma that have been used to extend such services to any other area of the Town of Goldsby, Oklahoma. The services and utilities include, without implied limitation, general municipal government, land use planning and regulation, fire protection, law enforcement, and solid waste disposal. The water utility is provided through the Goldsby Water Authority. The water utility shall be made available to the annexed territory on like basis and cost as the same is made available to all other areas of the Town of Goldsby, Oklahoma. The Town shall complete the implementation of the service plan within one hundred twenty (120) months from the date of annexation.


SECTION 4. EMERGENCY. It being necessary for the preservation of the public health, safety, peace and welfare of the citizens and residents of the Town of Goldsby, Oklahoma, that this Ordinance shall become effective immediately, an emergency is hereby declared to exist, by reason whereof, this Ordinance shall take full force and effect immediately upon its adoption, as provided by law.


