



AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GRANDFIELD, ANNEXING AN AREA ADJACENT TO THE CITY OF GRANDFIELD, INTO AND AS A PART OF THE CORPORATE LIMITS OF SAID CITY OF GRANDFIELD, AS SAID ANNEXATION THEREIN IS MORE PARTICULARLY DESCRIBED IN THIS ORDINANCE; AND DECLARING AN EMERGENCY.

WHEREAS, a written request has been presented to the City Commission of the City of Grandfield, Oklahoma signed by the owners of all of the land proposed to be annexed, requesting consideration, approval and passage of an ordinance extending and annexing into the corporate limits of the City of Grandfield certain real property adjacent or contiguous to the city limits of the City of Grandfield, as provided under the Charter and Ordinances of the City of Grandfield, and the laws of the State of Oklahoma, and said Commission after hearing the facts and being sufficiently advised, is of the opinion that all requirements necessary for the annexation of said property into the City of Grandfield and to extend the corporate limits thereof have been complied with as provided by the Charter and Ordinances of the City of Grandfield, and the laws of the State of Oklahoma as set forth in Title 11, Oklahoma Statutes, Section 21-101, *et seq.*

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GRANDFIELD, OKLAHOMA:

Section 1.

That said area shall become attached to and be within the corporate limits of the City of Grandfield, Oklahoma, and shall hereafter be considered an integral part of the corporate limits, and said corporate limits to the City of Grandfield, Oklahoma, are extended and enlarged so as to include all of the property described as follows, to-wit:

Beginning at the point where the North line of the right-of-way of the M.K. & T. Ry. Co. intersects the West line of the Southwest Quarter of Section Four (4), township Four (4) South, Range Fourteen (14) West of the I.M., THENCE North 210 Feet along the West line of the said Southwest Quarter of Section Four (4); THENCE Southeast parallel with the North line of the right-of-way of the M.K. & T. Ry. Co., 415 Feet to a point; THENCE South 210 Feet to the North line of the right-of-way of the M.K. & T. Ry. Co., to the point of beginning, containing 2 acres, more or less;

Being a portion of Section Nine (9), Township Four (4) South, Range Fourteen (14) WIM, BEGINNING AT A POINT 210 feet East of the Northwest corner of Section Nine (9), Township Four (4) South, Range Fourteen (14) West; THENCE South at right angles and parallel with the West boundary line of said Section 9 a distance of 210 feet; THENCE East at right angles and parallel with the North boundary line of said Section 9 a distance of 1,020 feet, more or less, to the intersection with the South right-of-way line of Wichita Falls & Northwestern Railway Company; THENCE Northwesterly along the South right-of-way line of Wichita Falls & Northwestern Railway Company 530.1 feet to the point of intersection with the North boundary line of said Section 9; THENCE West on the North boundary line of said Section 9 a distance of 708.6 feet to the place of beginning; and

BEGINNING at the Northwest corner of Section Nine (9), Township Four (4) South, Range

KNOW ALL MEN BY THESE PRESENTS that this map illustrates the properties that have been annexed into the corporate City Limits, to the City of Grandfield, Oklahoma by virtue of Ordinance No. 282, thereon describing the three annexed properties owned by Co-op Services Inc., that was filed at the office of the Tillman County Clerk on 03/08/2006, in Book 0833 and Page 85. Therefore, this map is to be filed and attached to Ordinance 282, at the office of the Tillman County Clerk.
