



AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GRANDFIELD, ANNEXING AN AREA WITH THE ADJACENT EXISTING, PLATED, DEDICATED RIGHT-OF-WAYS, ALL ADJACENT TO THE CITY OF GRANDFIELD, INTO AND AS A PART OF THE CORPORATE LIMITS OF SAID CITY OF GRANDFIELD, AS SAID ANNEXATION THEREIN IS MORE PARTICULARLY DESCRIBED IN THE ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, written requests have been presented to the City Commission of the City of Grandfield, Oklahoma signed by the owners of all of the land proposed to be annexed, requesting consideration, approval and passage of an ordinance extending and annexing into the corporate limits of the City of Grandfield certain real property adjacent or contiguous to the city limits of the City of Grandfield, as provided under the Charter and Ordinances of the City of Grandfield, and the laws of the State of Oklahoma, and said Commission after hearing the facts and being sufficiently advised, is of the opinion that all requirements necessary for the annexation of said property by the Charter and Ordinances of the City of Grandfield, and the laws of the State of Oklahoma as set forth in Title 11, Oklahoma Statutes, Section 212-101, et seq.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GRANDFIELD
OKLAHOMA:**

Section 1.

That said areas shall become attached to and be within the corporate limits of the City of Grandfield, Oklahoma, and shall hereafter be considered an integral part of the corporate limits, and said corporate limits to the City of Grandfield, Oklahoma, are extended and enlarged so as to include all of the property described as follows, to-wit:

Lots One (1) to Twelve (12), both inclusive, and Lots Nineteen (19) to Twenty-Four (24), both inclusive, in Block Twenty-Nine (29), including all the adjacent East 400 Block of the existing plated dedicated Sixth (6th) Street right-of-way and all the adjacent South 600 Block of the existing plated dedicated Grogan Street right-of-way; and

Lots One (1) to Twenty-Four (24), both inclusive, in Block Thirty (30); including all of the adjacent East 400 Block of the existing plated dedicated Seventh (7th) Street right-of-way and all the adjacent South 700 Block of the existing plated dedicated Grogan Street right-of-way; including all of the adjacent East 400 Block of the existing plated dedicated Eighth (8th) Street right-of-way; all in Maple Heights Addition to the Town of Grandfield, Oklahoma, according to the recorded plat thereof.

A portion of the South Bridge Boulevard right-of-way, being 66' in width,

A portion of the South Bridge Boulevard right-of-way, being 66' in width, beginning at a point described as the center of the intersection of the 8th Street and South Bridge Boulevard right-of ways, thence south a distance of 1080' to a point of ending; also described as: from a point of beginning, being the South East corner, of the North East Quarter (N.E.Q) of Section Eight (8), Township Four (4) South, Range fourteen (14) West, Tillman County, Oklahoma, thence thirty-three feet (33') West, thence one-thousand and eighty feet (1080') South, thence sixty-six feet (66') East, thence one-thousand and eighty feet (1080') North, thence thirty-three feet (33') West to the point of beginning;

Lots One (1) to Thirty-Two (32), both inclusive, in Block Six (6), including all of the adjacent East 400 Block of the existing plated dedicated Ninth (9th) Street right-of way; including all of the adjacent South 900 Block of the existing plated dedicated Texas Avenue right-of-way; including all of the adjacent East 400 Block of the existing plated dedicated Tenth (10th) Street right-of-way; and

Lots One (1) to Thirty-Two (32), both inclusive, in Block Seven (7); including all of the adjacent South 1000 Block of the existing plated dedicated Texas Avenue right-of-way; including all of the adjacent East 400 Block of the existing plated dedicated Eleventh (11th) Street right-of-way; and

Lots One (1) to Thirty-Two (32), both inclusive, in Block Eight (8); including all of the adjacent East 500 Block of the existing plated dedicated Tenth (10th) Street right-of-way; including all of the adjacent South 1000 block of the existing plated dedicated Burk Avenue; including all of the adjacent East 500 Block of the existing plated dedicated Eleventh (11th) Street right-of-way; all in the Hubbard Addition to the Town of Grandfield, Oklahoma, according to the recorded plat thereof.

Specifically including all alleys and street right-of-ways adjacent to the above described tracts.

Section 2. Effective Date

Passed and approve the 8th day of August, 2006. This ordinance will come into full force and effect on the 7th day of September, 2006.
