


ORDINANCE NO. 2005-7



AN ORDINANCE OF THE CITY OF HARRAH, OKLAHOMA, EXTENDING THE CORPORATE LIMITS OF THE CITY OF HARRAH AND DECLARING THE PROPERTY INCLUDED WITHIN SUCH LIMITS AS EXTENDED; ESTABLISHING THE LINES OF SUCH CORPORATE LIMITS AS EXTENDED, ZONING SAID PROPERTY TO R-2 MEDIUM POPULATION DENSITY RESIDENTIAL DISTRICT (TRACKS 6 & 7) REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; DECLARING SEVERABILITY ~~AND DECLARING AN EMERGENCY.~~

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HARRAH, OKLAHOMA:

SECTION 1: That the corporate limits of the City of Harrah be, hereby extended to include therein the following described property, to wit:

See attached Tracts 6 & 7

SECTION 2: That the City Council finds that the described tract is adjacent or contiguous to property already within the municipal limits and further the owners of the above described property have consented to said annexation and no further consents are necessary.

SECTION 3: REPEALER

That the City Council finds that appropriate zoning for the described tracts is noted in Exhibit "A".

SECTION 4: SEVERABILITY

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, said portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this ordinance.

SECTION 5: EMERGENCY

It being immediately necessary for the preservation of the public health, peace and safety of the City of Harrah and the inhabitants thereof, an emergency is hereby declared to exist by reason whereof, this ordinance shall be in full force and effect from and after its passage and approval, as provided by law.

R-2 MEDIUM POPULATION DENSITY RESIDENTIAL DISTRICT

TRACT 6

Part of the Northeast Quarter (NE/4) of Section Three (3), Township Eleven (11) North, Range One (1) East of the Indian Meridian, Oklahoma County, Oklahoma, being more particularly described as follows: Beginning 704.29 Feet East of the Northwest Corner of Government Lot 1; Thence South 527.65 Feet; Thence East 206.38 Feet; Thence North 527.65 Feet; Thence West 206.38 Feet to the point or place of beginning.

TRACT 7

A part of Government Lot one (1) in the Northeast Quarter (NE/4) of Section Three (3), Township Eleven (11) North, Range One (1) East of the Indian Meridian, Oklahoma County, Oklahoma, being more particularly described as follows: Commencing at the Northwest Corner of said Lot 1; Thence East along the North line of said Lot 1, a distance of 910.67 Feet to the point or place of beginning; Thence South a distance of 527.65 Feet; Thence East and parallel to the North line of the said Lot 1, a distance of 412.94 Feet to a point in the East line of said Lot 1; Thence North along the East line of the said Lot 1, a distance of 527.65 Feet to the Northeast Corner of the said Lot 1; Thence West along the North line of the said Lot 1 a distance of 412.78 Feet to the point or place of beginning. Said described tract containing 5 acres, more or less in Oklahoma County, State of Oklahoma.
