

AN ORDINANCE ANNEXING TO THE CITY OF HENRYETTA, OKLAHOMA, CERTAIN TERRITORY ADJACENT TO SAID CITY, AND INCREASING, EXTENDING AND ESTABLISHING THE CORPORATE LIMITS OF THE CITY OF HENRYETTA, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, it is the opinion of the City Council of the City of Henryetta, Oklahoma, that it is desirable at this time to extend the limits of said City, by annexing the hereinafter described tract and parcel of land to the City of Henryetta, Okmulgee County, State of Oklahoma, as the same is now constituted; and

WHEREAS, the acreage intending to be annexed is surrounded on three sides by property already annexed to the City of Henryetta; and

WHEREAS, said territory is adjacent to the City of Henryetta, Oklahoma, and under applicable laws, is subject to annexation; and

WHEREAS, authority is granted to said City by the statutes of the State of Oklahoma to annex additional territory and to extend the corporate limits of said City so as to include additional territory within the boundary of the City of Henryetta, Oklahoma;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HENRYETTA:

SECTION 1. That the following territory adjacent to the City of Henryetta, Oklahoma, as the same is now constituted, be and the same is, hereby annexed to and made a part of the City of Henryetta, State of Oklahoma, to-wit:

Commencing at the Southeast Corner of Lot Twenty (20), Highland Heights Addition; thence West along the South boundary of Lot 20, 300 feet to the point of beginning; thence South along the West boundary of the East Half of the South Half of the Southeast Quarter of the Southeast Quarter of the Southeast Quarter (E $\frac{1}{2}$ S $\frac{1}{2}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Ten (10), Township Eleven (11) North, Range Twelve (12) East and the West boundary of the East Half of the East Half of the Northeast Quarter of the Northeast Quarter (E $\frac{1}{2}$ E $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Fifteen (15), Township Eleven (11) North, Range Twelve (12) East to the Southwest Corner of the East Half of the East Half of the Northeast Quarter of the Northeast Quarter (E $\frac{1}{2}$ E $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 15, Township 11 North, Range 12 East; thence East along the South boundary of the North Half of the North Half (N $\frac{1}{2}$ N $\frac{1}{2}$) of Sections 15 and 14, both in Township 11 North, Range 12 East, to the Southeast Corner of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 14, Township 11 North, Range 12 East; thence North to the current City of

Commencing at the Southeast Corner of Lot Twenty (20), Highland Heights Addition; thence West along the South boundary of Lot 20, 300 feet to the point of beginning; thence South along the West boundary of the East Half of the South Half of the Southeast Quarter of the Southeast Quarter of the Southeast Quarter (E $\frac{1}{2}$ S $\frac{1}{2}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Ten (10), Township Eleven (11) North, Range Twelve (12) East and the West boundary of the East Half of the East Half of the Northeast Quarter of the Northeast Quarter (E $\frac{1}{2}$ E $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Fifteen (15), Township Eleven (11) North, Range Twelve (12) East to the Southwest Corner of the East Half of the East Half of the Northeast Quarter of the Northeast Quarter (E $\frac{1}{2}$ E $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 15, Township 11 North, Range 12 East; thence East along the South boundary of the North Half of the North Half (N $\frac{1}{2}$ N $\frac{1}{2}$) of Sections 15 and 14, both in Township 11 North, Range 12 East, to the Southeast Corner of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 14, Township 11 North, Range 12 East; thence North to the current City of Henryetta city limits located on the North right-of-way line of U.S. Interstate 40 Highway; thence West along the North line of said U.S. Interstate 40 Highway to the West line of Section 14, Township 11 North, Range 12 East; thence North along the West line of Section 14, to the Northwest Corner of Section 14, Township 11 North, Range 12 East; thence North 25 feet; thence West 330 feet to the point of beginning, all in Okmulgee County, State of Oklahoma.



ORDINANCE # 813

SECTION 2. That the present boundaries and limits of the City of Henryetta, Oklahoma, as they are now constituted, be, and the same are, hereby extended, so as to include and embrace within the limits of said City of Henryetta, State of Oklahoma, all of the above described land.


SECTION 3. The City of Henryetta will immediately provide all services to the territory annexed, with the exception of city sewer service. The Henryetta city sewer lines will be extended to the annexed areas as soon as the City is financially able to establish the service.

SECTION 4. That, because of the peace, health and safety of the citizens of the City of Henryetta, Oklahoma, an emergency is hereby declared to exist, and by reason of which this Ordinance shall be in full force and effect from and after its passage and approval.

PASSED AND APPROVED this 10th day of November, 1992; the emergency clause being resolved upon separately, and likewise approved this 10th day of November, 1992.


