ORDINANCE NO. 961

AN ORDINANCE ANNEXING TO THE CITY OF HENRYETTA, OKLAHOMA, CERTAIN TERRITORY ADJACENT TO SAID CITY, AND INCREASING, EXTENDING AND ESTABLISHING THE CORPORATE LIMITS OF THE CITY OF HENRYETTA, OKLAHOMA, AND DECLARING AN EMERGENCY.

WHEREAS, its is the opinion of the City Council of the City of Henryetta, Oklahoma, that it is desirable at this time to extend the limits of said City, by annexing the herein after described tract and parcel of land to the city of Henryetta, Okmulgee County, State of Oklahoma, as the same is now constituted; and

WHEREAS, a majority of the owners of the real property to be annexed have consented in writing to said annexation and the property is adjacent to the current city limits of the City of Henryetta.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HENRYETTA;


SECTION ONE (1): That the following territory adjacent or contiguous to the City of Henryetta, Oklahoma, as the same is, hereby annexed to and made a part of the City of Henryetta, State of Oklahoma, To-wit:

That part of Tracts 11 and 12 in HILLDALE PLACE, a subdivision of the South Half of the Northwest Quarter (S/2 NW/4) of Section One (1), Township Eleven (11) North, Range Twelve (12) East of the Indian Base and Meridian, Okmulgee County, State of Oklahoma being particularly described as follows: Beginning at the SE Corner of said Tract 11; thence North 467 feet; thence W. 94 feet; thence N. 18 feet; thence W. 225 feet; thence S. 485 feet to the SW corner of said Tract 11; thence E. 319 feet to the Point of Beginning. And beginning at the SE corner of said Tract 12; thence N. 390 feet; thence W. 230 feet; thence N. 87 feet; thence W. 89 feet to the W. line of said Tract 12; thence E. 319 feet to the Point of Beginning.

SECTION TWO (2): That the present boundaries and limits of the City of Henryetta, Oklahoma, as they are now constituted, be, and the same are, hereby extended, so as to include and embrace within the limits of said City of Henryetta, State of Oklahoma, all of the above described land.



PASSED and APPROVED this 20th day of April, 2004; the emergency clause being resolved upon separately and likewise, approved this 20th day of April, 2004.




