ORDINANCE NO. 2000-1

AN ORDINANCE OF THE TOWN OF HINTON, OKLAHOMA, PROVIDING FOR THE ANNEXATION OF ADDITIONAL TERRITORY HEREINAFTER DESIGNATED TO THE CORPORATE LIMITS OF SAID TOWN OF HINTON, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, it has been determined by the Town Council of the Town of Hinton, Oklahoma, that more than two weeks prior to this date a petition, in writing, from the Town Council, proposing annexation of said described property was mailed to all legal owners of the hereinafter described real estate, and that an Affidavit of Mailing on April 27, 2000, is attached.

WHEREAS, an accurate map of said territory proposed to be annexed by said petition has been presented to the Town Council of Hinton, Oklahoma; and

WHEREAS, it has been determined by said Town Council that all of the necessary steps have been taken and all of the relevant Statutes of the State of Oklahoma, and the ordinances of the Town of Hinton relating to such annexation procedures have been complied within their entirety.

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HINTON, OKLAHOMA:

Section 1. That the following described territory is hereby annexed to the Town of Hinton, Oklahoma:

The South Half (1/2) of Section Ten (10), Township 12, North, Range 11, West, of the I.M., Caddo County, Oklahoma; and

The Southeast Quarter (1/4) of Section Nine (9), Township 12, North, Range 11, West of the I.M., Caddo County, Oklahoma; and

The West Half (1/2) of Section fifteen (15), Township 12, North, range 11, West of the I.M., Caddo County, Oklahoma; and

The Northwest Quarter (1/4) of Section Twenty-seven (27), Township 12, North, Range 11, West of the I.M. Caddo County, Oklahoma: LESS AND EXCEPT the following tracts;


