



ORDINANCE # 817

AN ORDINANCE ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF HUGO, OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11 SECTION 21-105 OF THE OKLAHOMA STATUTES.

WHEREAS, pursuant to 11 O.S. § 21-103, the owners of three-fourth (in value) of real property of the territory, adjacent and contiguous to the City of Hugo, described in this ordinance, on the 10th day of April, 2008, petitioned the Hugo City Council to annex the following described real property, to-wit:

The E/2 of the SE/4 of the SE/4 of Section 28, township 6 South, Range 17 East in the County of Choctaw, City of Hugo, containing 4.84 acres more or less.

WHEREAS, notice of the proposed annexation of the territory described in this ordinance was published in the Hugo Daily News on the April 21, 2008 and April 28, 2008, pursuant to the requirements of 11 O.S. § 21-103.

NOW, therefore be it ordained by the City of Hugo, County of Choctaw, State of Oklahoma, that the following described lands, situated in Choctaw County, Oklahoma, to-wit:

The E/2 of the SE/4 of the SE/4 of Section 28, township 6 South, Range 17 East in the County of Choctaw, City of Hugo, containing 4.84 acres more or less.

Are herewith annexed to, included within the limits and shall be a part of the City of Hugo, Oklahoma.

It being necessary for the immediate preservation of the public peace, health and safety of the City of Hugo, Oklahoma and the inhabitants thereof, an emergency is hereby declared to exist, to wit: in order to provide police protection to said territory. By reason whereof, it is necessary that this Ordinance go into full effect and be of force immediately upon its passage and approval.


