

ORDINANCE # 881

AN ORDINANCE ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF HUGO, OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11 SECTION 21-105 OF THE OKLAHOMA STATUTES.

WHEREAS, pursuant to 11 O.S. § 21-105, more than three-fourths of the legal voters and the owners of at least three-fourths (in value) of certain real property contiguous and adjacent to the City of Hugo petitioned the City of Hugo to annex the following described real property located at 1204 South "K", in the County of Choctaw, State of Oklahoma to-wit:

The N/2 of the N/2 of the SW/4 of the SE/4 and the S/2 of the N/2 of the SW/4 of the SE/4 of Section 28, Township 6 South, Range 17 East, Choctaw County, Oklahoma.

WHEREAS, notice of the proposed annexation of the territory described in this ordinance was published in the Hugo Daily News on June 26, 2012, and July 3, 2012, pursuant to the requirements of 11 O.S. § 21-103.

NOW, therefore be it ordained by the City of Hugo, County of Choctaw, State of Oklahoma, that the following described lands, situated in Choctaw County, Oklahoma, to-wit:

The N/2 of the N/2 of the SW/4 of the SE/4 and the S/2 of the N/2 of the SW/4 of the SE/4 of Section 28, Township 6 South, Range 17 East, Choctaw County, Oklahoma.

are herewith annexed to, included within the limits and shall be a part of the City of Hugo, Oklahoma.

It being necessary for the immediate preservation of the public peace, health and safety of the City of Hugo, Oklahoma and the inhabitants thereof, an emergency is hereby declared to exist, to wit: in order to provide police protection to said territory. By reason whereof, it is necessary that this Ordinance go into full effect and be of force immediately upon its passage and approval.


