PETITION FOR INCORPORATION

COMES NOW, Clyde Shaver, Petitioner, and for his Petition to Incorporate IXL and in accordance with the laws of the State of Oklahoma, as set for in 11 O.S. Section 3-101, et. Seq. Respectfully states to the Board of County Commissioners as follows: to wit:

That the community of IXL is located approximately 3 miles north of Castain Okfuskee, County, Oklahoma; and

That the residents of the community of IXL have met to discuss the possibility of incorporating into a town. Clyde Shaver, a community resident, is organizing this project for the community; and,

Attached hereto as Exhibit "A" is a copy of a survey of the proposed town. This survey sets forth the legal description of the community of IXL, which has been platted and replatted according to the laws of the State of Oklahoma, as set forth in 11 O.S. 41-101. Et seq; that said survey shall serve as the official legal description of the proposed town; and,

That during Clyde Shaver Petitioner met individually with the resident voters and that attached hereto, and specifically made a part hereof, is a written consent of each person in favor of incorporating the proposed town. That the pole taken by the Petitioner yielded the following totals: 33 Residents, 25 Registered Voters and 25 Yes Votes to incorporate.

Attached hereto as Exhibit "B" is a petition signed by a majority of the resident population including names and addresses of persons residing in the community of IXL, the proposed town, as complied by the Incorporation Committee during May, 1998; and,

It is hereby proposed that two (2) wards be established in the proposed town:
Ward 1: S of 2nd St and Ward 2: N of 2nd St, and
five (5) at-large positions created on the proposed Board of Trustees; and,

That on 5-10-2000, the plat of the proposed Town of IXL and a copy of this Petition, including attached census, was posted.
