

ORDINANCE NO. 469

AN ORDINANCE ANNEXING THE CITY OF IDABEL, HEREINAFTER DESIGNATED AS AREA, THEREBY ALTERING, INCREASING AND ESTABLISHING THE CORPORATE LIMITS OF THE CITY OF IDABEL, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, In the opinion of the Council of the City of Idabel, Oklahoma, it is desirable to increase the limits of said City by annexing the hereinafter described parcels of land; and

WHEREAS, upon proper proof having been made, a majority of the owners of the whole number of acres in the lands hereinafter described having consented to be incorporated in the City of Idabel and to have the corporate limits of such city extended so as to include said area; and

WHEREAS, the Council of the City of Idabel, Oklahoma, in its judgment, finds that the annexation of said parcels of land will redound to the benefit of the City of Idabel, Oklahoma; and

WHEREAS, authority is vested in the City Council of the City of Idabel, according to 11 Okl. Stat. Section 481 (1969), to increase and alter the corporate limits of said City of Idabel in such manner as to include said area;

NOW, THEREFORE, be it ordained by the Mayor and Councilmen of the City of Idabel, Oklahoma, to-wit:

SECTION I. The following described tracts or parcels of land be included within the corporate limits of the City of Idabel, Oklahoma, to-wit:

TRACT ONE

All that part of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 7, Township 8 South, Range 24 East of the IBM, described as follows:

Begin 756.3 feet North of the SE Corner of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 7; run thence West 356 feet or to the existing fence; thence North 100 feet; thence East 356 feet; thence South 100 feet to the point of beginning;

TRACT TWO:

A part of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 7, Township 8 South, Range 24 East, described as follows:

Beginning 570.9 feet North of the Quarter Section Corner of Sections 7 and 8, Township 8 South, Range 24 East; thence North 285.4 feet; thence West 765.6 feet; thence South 285.4 feet; thence East 765.6 feet to the point of beginning, containing 5 acres;

TRACT FOUR:

Begin 756.3 feet and North 348 feet West of the SE Corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 7, Township 8 South, Range 24 East; run thence North 100 feet; thence West 417.6 feet; thence South 100 feet; thence East 417.6 feet to the point of beginning;

TRACT FIVE:

Begin 856.3 feet North and 50 feet West of the Quarter Section Corner between Sections 7 & 8, Township 8 South, Range 24 East; run thence North 50 feet; thence West 300 feet; thence South 50 feet; thence East 300 feet to the point of beginning.

SECTION II. That the above described and designated tracts be and the same is hereby made a part of Ward 4, Precinct 2, of the City of Idabel, Oklahoma.

SECTION III. In order to preserve the peace, health and safety of the inhabitants of the City of Idabel, Oklahoma, an emergency is hereby declared to exist whereby the provisions of this ordinance shall be in full force and effect from and after its passage, approval and publication, as provided by law.

UNANIMOUSLY PASSED and the Emergency Clause ruled upon separately this 27th day of March, 1984.
