**ORDINANCE NO. 1171**

**AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF JENKS, OKLAHOMA AND EXTENDING THE BOUNDARIES OF SAID CITY.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JENKS, TULSA COUNTY, OKLAHOMA:**

WHEREAS, the owners of more than a majority of the acres within the following described property, to-wit:

The N/2 of the SW/4 of the NW/4 of the NE/4 of Section Thirty-Four (34), Township Eighteen (18) North, Range Twelve (12) East of the Indian Base and Meridian, Tulsa County, State of Oklahoma.

have petitioned the City Council of the City of Jenks, Oklahoma, for the annexation of said property to the City of Jenks, which Petition has been filed with the City Clerk; and proper notice and statutory requirements have been met.

WHEREAS, the said tract of land is adjacent to and contiguous to the boundaries of the City of Jenks, Oklahoma;

WHEREAS, it is the desire of the City Council of the City of Jenks, Oklahoma, to annex said property and to extend the boundaries of the City so as to include the said property;






The boundaries of the City of Jenks are hereby extended so as to include said property.

The City Council of the City of Jenks further orders and directs the City Clerk to file a certified copy of this Ordinance with a map indicating the property annexed with respect to the City of Jenks, with the County Clerk of Tulsa County, Oklahoma.

Since the immediate operation of the provisions of the Ordinance is necessary for the preservation of public health, welfare and safety, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the City Council.


