ORDINANCE NO. 1183

An ordinance annexing the following described property to the City of Jenks, Oklahoma, and extending the boundaries of said City, to-wit: All land formed by accretion adjoining and abutting all that part of Government Lots Five (5), Seven (7) and Eight (8), and all of the Southwest Quarter of the Southeast Quarter situated North and East of the Midland Valley Railroad Right of Way, and all land formed by accretion adjoining and abutting Government Lots One (1) and Six (6) adjacent to but not within the corporate limits of the City of Tulsa, Oklahoma, all located in section Four (4), Township Seventeen (17) North, Range thirteen (13) East of the Indian Base and Meridian, Tulsa County, Oklahoma, and all lands which have accreted or may accrete thereto by operation of law, and all of the Arkansas River bed between said lands and the middle or center medial line of the stream or main channel of the Arkansas River; and, declaring an emergency.

WHEREAS, the owners of more than a majority of the acres within the following described tract have given consent to the City Council of the City of Jenks, Oklahoma, for the annexation of said property to the City of Jenks, to-wit:

All land formed by accretion adjoining and abutting all that part of Government Lots Five (5), Seven (7) and Eight (8), and all of the Southwest Quarter of the Southeast Quarter situated North and East of the Midland Valley Railroad Right of Way, and all land formed by accretion adjoining and abutting Government Lots One (1) and Six (6) adjacent to but not within the corporate limits of the City of Tulsa, Oklahoma, all located in section Four (4), Township Seventeen (17) North, Range thirteen (13) East of the Indian Base and Meridian, Tulsa County, Oklahoma, and all lands which have accreted or may accrete thereto by operation of law, and all of the Arkansas River bed between said lands and the middle or center medial line of the stream or main channel of the Arkansas River.


WHEREAS, proper notice including publication and mailings have been made, and the statutory requirements have been met for such annexation; and,

WHEREAS, the said tract of land is adjacent to and contiguous to the boundaries of the City of Jenks, Oklahoma; and,

WHEREAS, it is the desire of the City Council of the City of Jenks, Oklahoma, to annex said property and to extend the boundaries of the City so as to include the said property;

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JENKS, OKLAHOMA:

Does hereby annex the following described property to the City of Jenks, Oklahoma:



All land formed by accretion adjoining and abutting all that part of Government Lots Five (5), Seven (7) and Eight (8), and all of the Southwest Quarter of the Southeast Quarter situated North and East of the Midland Valley Railroad Right of Way, and all land formed by accretion adjoining and abutting Government Lots One (1) and Six (6) adjacent to but not within the corporate limits of the City of Tulsa, Oklahoma, all located in section Four (4), Township Seventeen (17) North, Range thirteen (13) East of the Indian Base and Meridian, Tulsa County, Oklahoma, and all lands which have accreted or may accrete thereto by operation of law, and all of the Arkansas River bed between said lands and the middle or center medial line of the stream or main channel of the Arkansas River.

The boundaries of the City of Jenks are hereby extended so as to include said property.






Emergency Clause ruled upon separately this 13th day of November, 2006.




