

ORDINANCE NO. 1248

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF JENKS, OKLAHOMA AND EXTENDING THE BOUNDARIES OF SAID CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JENKS, TULSA COUNTY, OKLAHOMA:


WHEREAS, all owners of the acreage within the following described property, to-wit:

Property located in the SW/4 of the SW/4 of Section 35 Township 18 North, Range 12 East, Tulsa County, Oklahoma and more particularly described as follows; Commencing at the SE Corner of the SW/4 of Section 35, thence west along the south line of said Section 35 for 780 feet, said point being the Point of Beginning; Thence North 584.83 feet to a point being on the South Right of Way line of West 120th Street South; Thence east along the south Right of Way line of West 120th Street South 755 feet to a point being on the west boundary of South Quanah Avenue West; Thence south 265 feet; Thence continuing south along the west boundary of South Quanah Avenue West to a point on the South Boundary of the SW/4 SW/4 of Section 35; Thence west along the south boundary of the SW/4 SW/4 of Section 35 for 705 feet to the Point of Beginning; Less and except the South 100 feet being an area along and parallel to the South boundary of the SW/4 SW/4 Section 35 of which the north 75 feet of the south 100 feet is the area previously annexed into the City of Jenks.

General Location: Northwest Corner of South Quanah Avenue West and West 121st Street South.

Have voluntarily petitioned the City Council of the City of Jenks, Oklahoma, for the annexation of said property to the City of Jenks, which Petition has been filed with the City Clerk; and proper notice and statutory requirements have been met.

WHEREAS, the said tract of land is adjacent to and contiguous to the boundaries of the City of Jenks, Oklahoma;

WHEREAS, it is the desire of the City Council of the City of Jenks, Oklahoma, to annex said property and to extend the boundaries of the City so as to include the said property;


BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JENKS, OKLAHOMA:

General Location: Northwest Corner of South Quanah Avenue West and West 121st Street South.

The City Council of the City of Jenks further orders and directs the City Clerk to file a certified copy of this Ordinance with a map indicating the property annexed with respect to the City of Jenks, with the County Clerk of Tulsa County, Oklahoma.




