AN ORDINANCE EXTENDING THE MUNICIPAL LIMITS OF THE TOWN OF KELLYVILLE, OKLAHOMA, MAKING FINDINGS OF FACT; ANNEXING AN AREA ADJACENT TO THE TOWN OF KELLYVILLE IN SECTIONS 7, 12, 13, 17 and 18, TOWNSHIP 17 NORTH, RANGES 10 and 11 EAST, CREEK COUNTY, OKLAHOMA INTO AND AS A PART OF THE MUNICIPAL LIMITS OF THE TOWN OF KELLYVILLE, OKLAHOMA; DESIGNATING THE ANNEXED TRACT TO BE RETAINED IN MUNICIPAL LIMITS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, a written consent has been presented to the Board of Trustees of the Town of Kellyville, Oklahoma, proposing consideration, approval and passage of an ordinance annexing into the municipal limits of the Town of Kellyville certain real property adjacent or contiguous to the Town under the laws of the State of Oklahoma, to wit:

The South 24.75 feet of the East 24.75 feet of the Southeast Quarter (SE/4) of Section 12, Township 17 North, Range 10 East, AND

The North 24.75 feet of the East 24.75 feet of the Northeast Quarter (NE/4) of Section 13, Township 17 North, Range 10 East, AND

The Southeast Quarter (SE/4) AND the Southeast Quarter of the Southwest Quarter (SE/4 SW/4) AND the South 24.75 feet of the Southwest Quarter of the Southwest Quarter (SW/4 SW/4) of Section 7, Township 17 North, Range 11 East, AND

The Northeast Quarter (NE/4) of Section 18, Township 17 North, Range 11 East, AND

The North 24.75 feet of the Northwest Quarter (NW/4) of Section 18 LESS the East 330 feet thereof, Township 17 North, Range 11 East,

All in Creek County, State of Oklahoma (collectively the "Territory"); and

WHEREAS, after due consideration of the facts and being sufficiently advised, the Board of Trustees hereby expressly finds that all requirements for annexation of the Territory into the Town of Kellyville and to extend the municipal limits thereof have been complied with as provided by the laws of the State of Oklahoma as set out in Okla. Stat. tit. 11 Sec. 21-101, et seq., including but not limited to the following:

- a. That the property to be annexed is adjacent or contiguous to property already within municipal limits of the Town of Kellyville, Oklahoma; and
- b. That the owners of a majority of the acres to be annexed have consented in writing to be annexed to and into the municipal limits of the Town of Kellyville; and

- c. That notice of the proposed annexation and public hearing has been published and mailed in compliance with statutory mandates; and
- d. That a public hearing of such annexation has been held by the governing body following publication and mailing of said notice in compliance with statutory mandates; and

that all other requirements of Okla. Stat. 11 Sec. 21-104 necessary for annexation of the Territory into the Town of Kellyville, Oklahoma have been fully complied with in advance of the issuance of this ordinance; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES, TOWN OF KELLYVILLE, OKLAHOMA:

Section 1: INITIAL ANNEXATION. That the following described tracts of land lying adjacent or contiguous to the present municipal limits of the Town of Kellyville, Oklahoma, to wit:

The South 24.75 feet of the East 24.75 feet of the Southeast Quarter (SE/4) of Section 12, Township 17 North, Range 10 East, AND

The North 24.75 feet of the East 24.75 feet of the Northeast Quarter (NE/4) of Section 13, Township 17 North, Range 10 East, AND

The Southeast Quarter (SE/4) AND the Southeast Quarter of the Southwest Quarter (SE/4 SW/4) AND the South 24.75 feet of the Southwest Quarter of the Southwest Quarter (SW/4 SW/4) of Section 7, Township 17 North, Range 11 East, AND

The Northeast Quarter (NE/4) of Section 18, Township 17 North, Range 11 East, AND

The North 24.75 feet of the Northwest Quarter (NW/4) of Section 18 LESS the East 330 feet thereof, Township 17 North, Range 11 East,

All in Creek County, State of Oklahoma (collectively the "Territory"),

be and the same are hereby annexed to the Town of Kellyville, Oklahoma, and the municipal limits of said Town are hereby extended to include the above described tract of land.

Section 2: SEVERABILITY. Should any section, subsection, sentence, provision, clause, or phrase hereof be held invalid, void, or unconstitutional for any reason, such holding shall not render invalid, void, or unconstitutional any other section, subsection, sentence, provision, clause, or phrase of this Ordinance, and the same are deemed severable for this purpose.

Section 3: EMERGENCY. This Ordinance being designated to protect the health and safety of the inhabitants of the Town of Kellyville, Oklahoma, an emergency is hereby declared





to exist whereby the same shall be in full force and effect from and after its adoption and publication.


