ORDER ANNEXING TERRITORY TO TOWN

OF KELLYVILLE, OKLAHOMA

NOW on this 13th day of August, 1990, this Petition for annexation of the following described property:

Beginning at the point 1,320 Feet East of the Southwest (SW) corner of Section 13, Township 17 North, Range 10 East (Sec. 13, T-17-N, R-10-E) THENCE East 3,960 Feet, THENCE North 13,200 Feet to the Southeast (SE) Corner of the North Half of Section 1, Township 17 North, Range 10 East (Sec. 1, T-17-N, R-10-E) THENCE West along the South line of said North Half of Section 1 to a point of intersection with the West Right-of-Way Boundary of Oklahoma S.H. 66, THENCE Northerly along said Right-of-Way Boundary to a point of intersection with the North Line of the South Half of the North Half of said Section 1, THENCE West along said North line to a point of intersection with the East Right-of-Way Boundary of the Turner Turnpike, THENCE Southwesterly along said Turner Turnpike Right-of-Way Boundary to a point of intersection with the South line of Section 16, Township-17-North, Range-10-East (Sec. 16, T-17-N, R-10-E), THENCE East along said South Line to the Southwest (SW) Corner of Section 15, Township-17-North, Range-10-East (Sec. 15, T-17-N, R-10-E), THENCE East along the South line of said Section 15 to the Southwest (SW) Corner of Section 14, Township-17-North, Range-10-East (Sec. 14, T-17-N, R-10-E), THENCE East along the South line of said Section 14 to a point of intersection with the West Boundary line of the corporate limits of the Town of Kellyville, THENCE North 67 Feet, THENCE West parallel with and 67 Feet North of the South line of said Sections 14, 15, and 16 to a point 67 Feet East of said Turner Turnpike Right-of-Way Boundary, THENCE Northeasterly parallel with and 67 Feet East of said Turner Turnpike Right-of-Way Boundary to a point 67 Feet South of the North line of the South Half of the North Half of Section 1, Township-17-North, Range 10 East (Sec. 1, T-17-N, R-10-E), THENCE parallel with and 67 Feet South of said North line of the South Half of the North Half of said Section 1 East to a point 67 Feet West of the West Right-of-Way Boundary of Oklahoma S.H. 66, THENCE Southerly parallel with and 67 Feet West of said Right-of-Way Boundary to point 67 Feet

R-10-E), THENCE West 3,893 Feet THENCE South 67 Feet to the point of beginning.




