AN ORDINANCE ANNEXING CERTAIN LANDS IN SECTION 19, TOWNSHIP 17 NORTH, RANGE 12 EAST, IN CREEK COUNTY, OKLAHOMA TO THE TOWN OF KIEFER, OKLAHOMA, AND INCLUDING THE SAME WITHIN THE INCORPORATED LIMITS OF SAID TOWN.

WHEREAS, the Town Board of Trustees desires to annex into the Town of Kiefer certain property in that part of Section 19, Township 17 North, Range 12 East, Creek County, Oklahoma described as follows, to-wit:

A tract of land located in Section 19, Township 17 North, Range 12 East, Creek County, Oklahoma, more particularly described as follows:

BEGINNING AT A POINT 136.25' NORTH OF THE SE CORNER OF THE NW1/4 NE1/4, SECTION 19, T17N, R12E, THENCE WEST 161.25', THENCE N12 04' 56"W 579.60', THENCE N 51 50'03" E 359.40', THENCE SOUTH 788.85' TO POINT OF BEGINNING.

AND

A tract of land located in Section 19, Township 17 North, Range 12 East, Creek County, Oklahoma, more particularly described as follows:

BEGINNING AT A POINT 100.0' SOUTH AND 161.25' WEST OF THE SE CORNER OF THE NW1/4, NE1/4, SECTION 19, T17N, R12E, THENCE NORTH 236.25', THENCE N12 04' 56" WEST 579.60', THENCE S51 50'03" W 150.0', THENCE SOUTH 710.32', THENCE EAST 239.25' TO POINT OF BEGINNING.

WHEREAS, said land is contiguous and adjacent to the corporate limits of the Town of Kiefer, Oklahoma, and the land has been platted and recorded in the Office of the County Clerk, and the Board of Trustees of the Town of Kiefer, Oklahoma is of the opinion that the said territory should be annexed to the Town of Kiefer, Oklahoma.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF KIEFER, OKLAHOMA:

SECTION 1: TERRITORY ANNEXED. That the hereinabove described land be, and is hereby annexed to the Town of Kiefer, Oklahoma, and included within the incorporated limits of the Town of Kiefer, Oklahoma, in accordance with Title 11 Okla. Stat. § 21-104.




