

AN ORDINANCE ANNEXING TO THE CITY OF KINGFISHER, OKLAHOMA, THE FOLLOWING DESCRIBED PROPERTY:

The Northeast Quarter (NE $\frac{1}{4}$) of Section 33, Township 16 North, Range 7WIM Kingfisher County, Oklahoma, adding same to precinct NO 2 of the City of Kingfisher, Oklahoma; and Declaring an Emergency.

BE IT ENACTED BY THE MAYOR AND THE BOARD OF CITY COMMISSIONERS OF THE CITY OF KINGFISHER, OKLAHOMA:

- Section 1. THAT, WHEREAS, a petition in writing has been filed with the Board of City Commissioners by not less than three fourths of the legal voters residing upon the Northeast Quarter (NE $\frac{1}{4}$) of Section 33, Township 16 North, Range 7WIM Kingfisher County, Oklahoma; and by not less than three-fourths of the owners of value of land involved, praying that said property so described be annexed to the City of Kingfisher, Oklahoma and to extend the limits of the City of Kingfisher, Oklahoma to include said property so described.
- Section 2. WHEREAS as provided by Section 481 of title 11 OSA territory separated from the present boundary by a strip constituting a county highway and 13th ^{street} extension of the City of Kingfisher, Oklahoma, being a strip 66 feet in width shall be considered contiguous and by power granted in Section 482 of OSA said land may be considered for the purpose of this ordinance contiguous.
- Section 3. WHEREAS, it is considered by the Board of City Commissioners that the annexation of said tract will redound to the benefit and best interest of the City of Kingfisher, Oklahoma, and said application is well taken and considered essential to the welfare to the City of Kingfisher, Oklahoma.
- SECTION 4. BE, IT THEREFORE, ORDAINED that from and after the passage of this Ordinance that said tract so described, the title of which is in the names of the persons shown of record, three fourths of whom have petitioned for annexation, be and the same is hereby annexed to the City of Kingfisher, Oklahoma, and that from and after the passage of this ordinance and the publication thereof, and the compliance with all the laws and regulations pertaining to annexation to a municipality, such shall constitute a part of the official City limits of the City of Kingfisher, Oklahoma, extending to said property all the rights, benefits and privileges of all the inhabitants of the City of Kingfisher, Oklahoma; and upon the filing of a certified copy of this Ordinance with an accurate map of the territory annexed in the office of the County Clerk of Kingfisher County, Oklahoma, such shall be and constitute a part of the City of Kingfisher, Oklahoma, and the limits are extended to include said property so described.
- Section 5. Be it further enacted and provided that said tract shall be a part of Precinct No 2 in the City of Kingfisher, Oklahoma.
- SECTION 6. EMERGENCY: WHEREAS, it appears for the best interest and for the peace, welfare and comfort of the inhabitants of the City of Kingfisher, Oklahoma, that this Ordinance shall be declared immediately in full force and effect. THEREFORE,

approval, passage and publication of this Ordinance an emergency does exist and the same shall become in full force and effect immediately thereafter.
