

ORDINANCE NO. 08-03


AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF KREBS, COUNTY OF PITTSBURG, STATE OF OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11, OKL. STAT. LAWS 1977, SEC. 21-101 ET SEQ.; BY ANNEXING THERETO A CERTAIN TRACT OF LAND CONTIGUOUS AND ADJACENT TO AND NOT EMBRACED WITHIN THE PRESENT CITY LIMITS OF THE CITY OF KREBS, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Krebs, being advised in the premises finds that the territory hereinafter described as contiguous and adjacent to the City of Krebs and is not now embraced within the present city limits, and therefore, the City Council of the City of Krebs has jurisdiction to annex the hereinafter described territory into the corporate limits of said city.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Krebs that the corporate limits of said city be and are hereby extended and increased so as to include and embrace that territory hereinafter more particularly described as follows:

A tract of land containing 30.00 acres, more or less, in the SE¼ of Section 28, Township 6 North, Range 15 East, Pittsburg County, State of Oklahoma, more particularly described as follows: Commencing at the SE corner of said SE¼; thence N 01° 19' 33" W along the East line of said SE¼ a distance of 702.32 feet to the true Point of Beginning; thence N 87° 02' 55" W a distance of 163.78 feet; thence S 57° 36' 53" W a distance of 209.91 feet; thence S 37° 09' 19" W a distance of 10.71 feet; thence S 6° 10' 42" W a distance of 34.39 feet; thence S 13° 51' 23" W a distance of 22.10 feet; thence S 36° 56' 40" W a distance of 51.53 feet; thence S 88° 57' 41" W a distance of 3.00 feet; thence S 01° 19' 33" E a distance of 100.00 feet; thence S 88° 57' 41" W a distance of 897.92 feet to a point on the Easterly R/W of U.S. Highway No. 69; thence N 11° 02' 19" E along said R/W a distance of 122.65 feet; thence Northwesterly on a curve to the left having a radius of 813.94 a distance of 208.21 feet along said R/W; thence N 25° 41' 43" W along said R/W a distance of 263.05 feet; thence along said R/W Northwesterly on a curve to the right having a radius of 654.01 feet a distance of 173.31 feet; thence N 10° 30' 44" W along said R/W a distance of 258.06 feet; thence S 88° 57' 41" E a distance of 1574.08 feet to a point on the East line of said SE¼; thence S 01° 19' 33" E a distance of 675.50 feet to the true Point of Beginning,

And such territory is hereby annexed and declared to be a part of the City of Krebs, Oklahoma.







This ordinance is hereby directed to be published, distributed and recorded as required by law.


Passed by the City Council of the City of Krebs with the Emergency Clause acted on separately on the 18th day of August, 2008.
