ORDINANCE NO. 97 - 4

AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF KREBS, COUNTY OF PITTSBURG, STATE OF OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11, OKL. STAT. LAWS 1977, SEC. 21-103 ; BY ANNEXING THERETO A CERTAIN TRACT OF LAND CONTIGUOUS AND ADJACENT TO AND NOT EMBRACED WITHIN THE PRESENT CITY LIMITS OF THE CITY OF KREBS; AND DECLARING AN EMERGENCY.

WHEREAS, a request and consent in writing has been presented to the City Council of the City of Krebs signed by the owners of a majority of the acres to be annexed to the City of Krebs, hereinafter described and the City Council being advised in the premises finds that such territory is contiguous and adjacent to the City of Krebs and is not now embraced within the present City's limits, and therefore the City Council of the City of Krebs has jurisdiction to annex said territory hereinafter described to said City.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Krebs that the corporate limits of said city be and are hereby extended and increased so as to include and embrace within the corporate limits of the City of Krebs that territory more particularly described as follows:

The Northwest Quarter Northwest Quarter (NW NW) Section Thirty-three (33) Township Six (6) North, Range Fifteen (15) East and Lot Seven (7), Townsite Addition No. Seven (7), Pittsburg County, Oklahoma; and

A piece, parcel or strip of land two (2) feet in width, the same being one (1) foot either side of the center line hereinafter described, to-wit: Commencing at a point on the South lot line of Lot (Seventeen) 17, Townsite Addition No. Seven (7), Pittsburg County, Oklahoma, located one (1) foot East of the Southwest Corner of said Lot; thence North and parallel with the West lot lines of Lots Seventeen (17), Eight (8) and Five (5) to a point located one (1) foot North of the point of intersect with the South right-of-way boundary line of the MKT Railroad right-of-way; thence Northwesterly and parallel with said South right-of-way boundary line to a point located one (1) foot North of the point of intersect with the South lot line of Lot Six (6), Townsite Addition No. Seven (7); thence West and parallel with the South lot line of Lot Six (6) to a point located one (1) foot East of the East lot line of said Lot Seven (7); thence North and parallel with said East lot line to a point located one (1) foot North of the point of intersect with

the One-Half (1/2) section line of Section Thirty-Three (33), Township Six (6) North, Range Fifteen (15) East, Pittsburg County, Oklahoma; thence West and parallel with said One-Half (1/2) section line to a point located one (1) foot East of the West section line of said section; thence North and parallel with said West section line to a point located one (1) foot South of the South line of the Northwest Quarter Northwest Quarter (NW NW) of said Section Thirty-Three (33); thence East and parallel with said South line to a point located one (1) foot East and one (1) foot South of the East line of said Northwest Quarter Northwest Quarter (NW NW); thence North and parallel with the said East line to a point located one (1) foot South of the South right-of-way boundary line of that county section line roadway which traverses the North section line of said Section Thirty-Three (33), commonly known as Hereford Lane; thence East and parallel with said South right of way boundary line to a point located one (1) foot West of the East section line of said Section Thirty-Three (33); thence South and parallel with said East section line to a point of intersect with the North lot line of Lot One (1), Townsite Addition No. Seven (7), located one (1) foot West of the Northeast corner of said Lot One (1); thence South and parallel with the East lot lines of Lots One (1), Twelve (12), Thirteen (13), Twenty-One (21), Thirty (30), Thirty-Two (32) and Forty-One (41) of Townsite Addition No. Seven (7) to a point of intersect with the North right-of-way boundary line of Creek Avenue in the City of Krebs, Pittsburg County, Oklahoma, for a point of ending, all in Pittsburg County, Oklahoma, according to the official maps or plat thereof.

and such territory is hereby annexed and declared to be a part of the City of Krebs, Oklahoma.



This ordinance is hereby directed to be published, distributed and recorded as required by law.

EMERGENCY CLAUSE: It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason of which this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.


