ORDINANCE NO. 97-6

AN ORDINANCE EXTENDING AND INCREASING THE CORPORATE LIMITS OF THE CITY OF KREBS, COUNTY OF PITTSBURG, STATE OF OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11, OKL. STAT. LAWS 1977, SEC. 21-101 ET SEQ.; BY ANNEXING THERETO A CERTAIN TRACT OF LAND CONTIGUOUS AND ADJACENT TO AND NOT EMBRACED WITHIN THE PRESENT CITY LIMITS OF THE CITY OF KREBS, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Krebs, being advised in the premises finds that territory hereinafter described is contiguous and adjacent to the City of Krebs and is not now embraced within the present city limits, and therefore, the City Council of the City of Krebs has jurisdiction to annex the hereinafter described territory into the corporate limits of said city.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Krebs that the corporate limits of said city be and are hereby extended and increased so as to include and embrace that territory hereinafter more particularly described as follows:

All of Lots One (1) through Six (6) and Lots Eight (8) through Twenty-One (21); Lots Thirty (30) through Thirty-Two (32) and Lot Forty-One (41), in Townsite Addition No. Seven (7), Pittsburg County, Oklahoma, not previously annexed to the City of Krebs, Oklahoma; and all that part of the North Half (N/2) of Section Thirty-Three (33), Township Six (6) North, Range Fifteen (15) East, Pittsburg County, State of Oklahoma, less the Northwest Quarter Northwest Quarter (NW NW) thereof, not previously annexed to the City of Krebs, Oklahoma, located South of a line described as commencing at a point on the East line of the Northwest Quarter Northwest Quarter (NW NW) of said Section Thirty-three (33), and two (2) feet South of the South right-of-way boundary line of that county section line roadway which traverses the North section line of said Section Thirty-three (33), commonly known as Hereford

Lane; thence East and parallel with said South right-of-way boundary line to a point on the East section line of said Section Thirty-three (33), located two (2) feet South of said South right-of-way boundary line.

and such territory is hereby annexed and declared to be a part of the City of Krebs, Oklahoma.

The map or plat attached to this ordinance show the legal boundaries of the territory annexed, and the same is hereby adopted as the official map and plat thereof. That the final service plan adopted by the City Council on the date of the adoption of this ordinance pursuant to provisions of Title 11, Okl. Stat. Sec. 21-103 (B) is hereby incorporated by reference as part of this ordinance.

This ordinance is hereby directed to be published, distributed and recorded as required by law.

EMERGENCY CLAUSE: It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason of which this ordinance shall take effect and be in full force and effect from and after its passage, approval and publication.

Passed by the City Council of the City of Krebs with the Emergency Clause acted on separately on the 16th day of December, 1997.
