TOWN OF LAMAR, OKLAHOMA

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE TOWN OF LAMAR, OKLAHOMA, AND DESIGNATING THE AREAS OR SECTIONS INCLUDED IN SUCH EXTENSION AND ANNEXATION, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF LAMAR STATE OF OKLAHOMA, COUNTY OF HUGHES.

Section 1. It is the judgement of the mayor and council of the TOWN of LAMAR, OKLAHOMA, that it will rebound to the benefit of the TOWN of LAMAR, to annex and take the property hereafter described within the limits of the TOWN of LAMAR, OKLAHOMA. Furthermore four sides of the Town limits are adjacent to the described sections of land on property already the TOWN OF LAMAR. The Corporated limits of the TOWN OF LAMAR, OKLAHOMA be and the same are hereby extended to include the following described real property in HUGHES COUNTY, STATE OF OKLAHOMA.

Section 2. Emergency, Whereas it being immediately necessary for the preservation of the peace, health and safety of LAMAR and the inhabitants thereof that the provision of this ordinance be put in full force and effect, an Emergency is hereby declared to exist by reason whereof this ordinance shall take effect and be in full force from and after its passage by law.
