


ORDINANCE NO. 2003-6



AN ORDINANCE ANNEXING PROPERTY INTO THE TOWN OF LANGLEY, MAYES COUNTY, OKLAHOMA, AND DECLARING AN EMERGENCY.

WHEREAS, Wade J. Silzer, is the owner of certain real property more particularly described as the West 617.0 feet of the South 611.0 feet of the Southwest Quarter of the Southwest Quarter of Section 34, Township 24 North, Range 21 East of the Indian Base and Meridian, Craig County, Oklahoma, containing 8.65 acres more or less; and,


WHEREAS, the owner of the above described property has requested that such real property be annexed into the Town Limits of the Town of Langley, Oklahoma; and,

Silzer to annex the aforesaid and described real property is hereby approved and the Town of Langley, Oklahoma, on this 6 day of March, 2003, annexes into its municipal limits, the West 617.0 feet of the South 611.0 feet of the Southwest Quarter of the Southwest Quarter of Section 34, Township 24 North, Range 21 East of the Indian Base and Meridian, Craig County, Oklahoma, such property containing 8.65 acres more or less.


