

ORDINANCE NO.: 2006-2

An Ordinance extending the corporate boundaries of the Town of Laverne, Oklahoma, as to include the following described tract of real estate, and making the same subject to the jurisdiction thereof and declaring an emergency;

WHEREAS, **Harper County Development Authority**, a public trust, is the owner of the following described real estate, to-wit:

A tract of land situated in the Northwest Quarter (NW/4) of Section 28, Township 26 North, Range 25 WIM, Harper County, Oklahoma, more particularly described as follows:

Beginning at a point a distance of 1570.42 feet East (N88°51'47"E) of the section line and a distance of 721.16 feet South (S00°02'56"W) of the Northwest corner of said Section 28 (said point of beginning being the Southwest corner of the Laverne City Park); thence continuing South (S00°02'56"W) a distance of 367.09 feet; thence East (N89°49'29"E) a distance of 1098.79 feet to a point 23.00 feet West of the East boundary of the NW/4 of said Section 28; thence North (N00°01'07"E) and parallel with said East boundary a distance of 327.01 feet; thence West (S89°49'29"W) a distance of 575.43 feet; thence North (N00°02'56"E) a distance of 60.06 feet to the Southeast corner of said City Park; thence West (S89°49'29"W) a distance of 523.20 feet to the point of beginning. Said tract containing 8.4650 acres.

AND WHEREAS, it appearing to the Board of Trustees of the said Town of Laverne, Oklahoma, that all statutory requirements and notices have been completed and are all in due and legal form;

AND WHEREAS, said Town of Laverne, Oklahoma, in its discretion and within its jurisdiction deems it proper to increase said town limits for the benefit of said municipality.


NOW THEREFORE, BE IT ORDAINED, BY THE BOARD OF TRUSTEES OF THE TOWN OF LAVERNE, HARPER COUNTY, OKLAHOMA, in regular session assembled:


(1) That the above tract of land as designated be and the same is hereby annexed to and made a part of the Town of Laverne, Oklahoma, and the boundaries of the Town of Laverne, Oklahoma, be and are hereby extended so as to include said tract and the same is hereby made a part of and included within the corporate limits of said Town, and fully subject to the jurisdiction thereof. The final service plan is by reference incorporated herein and made a part of this ordinance.

(2) **EMERGENCY CLAUSE:** An emergency is hereby declared to exist by reason of which it is deemed necessary for the immediate preservation of the public health, peace and safety and welfare, and for the best interest of the public, that this ordinance shall take effect and be in full force and effect immediately upon its passage, approval and publication, according to law.
