AN ORDINANCE PROVIDING FOR THE ATTACHMENT OF CERTAIN PARCELS OF LAND INTO THE CITY OF LAWTON, COMANCHE COUNTY, OKLAHOMA, CLASSIFYING SAID TERRITORY AS "TEMPORARY" A-1 (GENERAL AGRICULTURAL DISTRICT) ZONING CLASSIFICATION FOR A PERIOD NOT EXCEEDING ONE (1) YEAR, AND DECLARING AN EMERGENCY.

Emergency Ordinance


WHEREAS, the tracts of land described in Section One (1) hereof are bounded on, adjacent to, and abutting on property already within the City of Lawton, Oklahoma, on at least three (3) sides; and

WHEREAS, it is deemed necessary and desirable that said described tracts of land be added and attached to the City of Lawton, Oklahoma.

NOW, THEREFORE, be it ordained by the Mayor and City Council of the City of Lawton, Oklahoma, that:

SECTION 1. The city limits of the City of Lawton, Oklahoma, shall constitute and be and include within the limits of said city the following described territory, to-wit:

- ✓ All of Section 14, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma; less and except the South thirty-three (33) feet of said Section 14; and less and except the West 330 feet of the North 890 feet of the North-west Quarter (NW/4) of said Section 14. (629.3 ac.)
- ✓ All of Section 15, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma; less and except the South thirty-three (33) feet of said Section 15. (636.0 ac.)
- ✓ All of Section 16, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma; less and except the South thirty-three (33) feet of said Section 16. (636.0 ac.)
- ✓ All of Section 17, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma; less and except the South thirty-three (33) feet and the West thirty-three (33) feet of said Section 17. (632.0 ac.)
- ✓ The West thirty-three (33) feet of Section 13, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma. (4.0 ac.)
- ✓ The South thirty-three (33) feet of the West thirty-three (33) feet of Section 12, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma. (.025 ac.)
- ✓ The South thirty-three (33) feet of Section 11, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma; less and except the West 330 feet of the South 33 feet of said Section 11. (3.75 ac.)

- ✓ The South thirty-three (33) feet of Section 10, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma. (4.0 ac.)
- ✓ The South thirty-three (33) feet of Section 9, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma. (4.0 ac.)
- ✓ The South thirty-three (33) feet of Section 8, Township One North (T1N), Range Twelve West (R12W), I.M., Comanche County, Oklahoma; less and except the West fifty (50) feet of the South 33 feet of said Section 8. (3.9 ac.)

all of said tracts being located in said Comanche County, Oklahoma, be and all the same are hereby attached to and a part of the City of Lawton, Oklahoma, for all purposes.

SECTION 2 . The city limits of the City of Lawton, Oklahoma, are hereby extended to include for all purposes the above described parcels of land.

SECTION 3 . Said tracts shall be zoned and classified as "temporary" A-1 (General Agricultural District) zoning classification for a period of time not exceeding one (1) year from the effective date of this ordinance.

SECTION 4 . The Municipal Service and Implementation Plan pursuant to Oklahoma Statute, Title II, Section 21-103, is hereby incorporated into and made part of this ordinance.

SECTION 5 . Emergency . Whereas, it being immediately necessary for the preservation of the peace, health, and safety of the City of Lawton and the inhabitants thereof that the provisions of this ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this ordinance shall take effect, and be in full force from and after its passage, as provided by law.
