AN ORDINANCE ANNEXING TO THE TOWN OF LEEDEY, OKLAHOMA
PROPERTY SITUATED

WHEREAS, the Town Council of the Town of Leedeey, Oklahoma deems it proper to annex the property hereinbelow described and that such annexation will rebound to the benefit of said Town of Leedeey, and,

WHEREAS, the owners of the land lying within the area proposed for annexation have submitted a request to the Town of Leedeey that the subject property be annexed by and to the Town of Leedeey, and hereby made a part of the land area within the corporate boundaries of the Town of Leedeey, and,

WHEREAS, the subject property is hereby described as:

A tract of land situated in the SE/4 of Section 17, T16N, R20 W.I.M., Dewey County, Oklahoma, more particularly described as follows:

Beginning at a point on the South boundary of said SE/4 a distance of 733.00 feet East (N89°39'58"E) of the Southwest corner of the SE/4 of said Section 17, THENCE continuing East (N89°39'58"E) a distance of 430.00 feet, THENCE North (N0°34'39"E) a distance of 1093.00 feet, THENCE West (S89°39'58"W) a distance of 430.00 feet, THENCE South (S0°34'39"W) a distance of 1093.00 feet to the point of beginning, said tract containing 10.7881 acres.

NOW, THEREFORE, be it ordained by the Town Council of the Town of Leedeey, Oklahoma.

SECTION I. The subject property is hereby annexed and added to the Town of Leedeey, Oklahoma.

SECTION II. The subject property shall be zoned None.

SECTION III. It is deemed and declared necessary for the preservation of the public health, peace and safety that the subject property should be annexed and zoned from and after its passage, approval and publication.
