AN ORDINANCE ANNEXING TERRITORY ADJACENT TO THE CITY LIMITS OF THE CITY OF MADILL, OKLAHOMA, WITH A WRITTEN CONSENT OF THE REGISTERED VOTER AND OWNER OF ALL OF THE PROPERTY SOUGHT TO BE ANNEXED TO THE MUNICIPALITY, SAID TERRITORY BEING DESCRIBED AS FOLLOWS:

WHEREAS, the owner of all of the acres described in section 1 of this ordinance, said land being adjacent to the City of Madill, Oklahoma, having consented in writing that the same be annexed to and added to the city limits of the City of Madill, Oklahoma, and having presented her signed petition seeking said annexation,

NOW THEREFORE, be it ordained by the Council of the City of Madill, Oklahoma that:

- Section 1: The area for which annexation is sought is described as follows:
SEC 20-5-5; BEG AT THE NW COR OF SE/4; THENCE S89*52' 12"E 1290.23'-S 979.79'-W 513.50'-N53*57' 17"W 960.65'-N416.28' TO POB
- Section 2: The increase of the City by the annexation of the hereinbefore described property will redounded to the benefit of the City and the same is hereby annexed.
- Section 3: A copy of the ordinance, together with an accurate map of the territory annexed, certified by the Mayor and the City Clerk, shall be filed in the Office of the County Clerk of Marshall County, Oklahoma.
- Section 4: Severability: If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.
