ORDINANCE #762

AN ORDINANCE ANNEXING TERRITORY ADJACENT TO THE CITY LIMITS OF THE CITY OF MADILL, OKLAHOMA, WITH THE WRITTEN CONSENT OF THE OWNERS OF AT LEAST A MAJORITY OF THE ACRES TO BE ANNEXED TO THE MUNICIPALITY, SAID TERRITORY BEING DESCRIBED AS FOLLOWS:

ALL OF HIGHWAY NO. 70 RIGHT-OF-WAY, LOCATED IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 6 SOUTH, RANGE 6 EAST INDIAN BASE AND MERIDIAN, MARSHALL COUNTY, OKLAHOMA.

Subject to Easements, Restrictions and Right-of-Ways, recorded or implied, if any, thereof.

WHEREAS, the owners of at least a majority of the acres described in section 1 of this Ordinance, said land being contiguous with and adjacent to the City of Madill, Oklahoma, have consented in writing that the same be annexed to and added to the City limits of the City of Madill, Oklahoma;

NOW THEREFORE, be it ordained by the Council of the City of Madill, Oklahoma that:

Section 1: The area for which annexation is sought is described as follows:

ALL OF HIGHWAY NO. 70 RIGHT-OF-WAY, LOCATED IN THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 6 SOUTH, RANGE 6 EAST INDIAN BASE AND MERIDIAN, MARSHALL COUNTY, OKLAHOMA.

Subject to Easements, Restrictions and Right-of-Ways, recorded or implied, if any, thereof.

Section 2: The increase of the City by the annexation of the hereinbefore-described property will redound to the benefit of the City and the same is hereby annexed.




Section 3: A copy of the Ordinance, together with an accurate map of the territory annexed, certified by the Mayor and the City Clerk, shall be filed in the office of the County Clerk of Marshall County, Oklahoma.

Section 4: **SEVERABILITY.** If any section, sub-section, sentence, clause, phrase, or portion of this Ordinance, is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provisions and such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 5: **EMERGENCY CLAUSE.** This Ordinance being designated to protect the health and safety of the inhabitants of the City of Madill, Oklahoma, an emergency is hereby declared to exist whereby the same shall be in full force and effect from after its adoption.


