


ORDINANCE NO. 430-Amended



AN ORDINANCE ANNEXING TO AND INCLUDING WITHIN THE CORPORATE LIMITS OF THE CITY OF MANGUM, OKLAHOMA, A CERTAIN UNPLATTED TRACT AND PARCEL OF LAND LYING IN SECTION 34, T5N, R22 WIM IN GREER COUNTY, OKLAHOMA, AND DECLARING AN EMERGENCY.

WHEREAS, the owner of all the land hereinafter described has formally petitioned that said land be incorporated within the city limits of the City of Mangum, Oklahoma; and,

WHEREAS, said land is contiguous and adjacent to the City of Mangum, Oklahoma, and said City will be benefited by the inclusion of said tract within the corporate limits;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE CITY OF MANGUM, OKLAHOMA:


Section 1. That the following described land, which is contiguous to the corporate limits of the City of Mangum, Oklahoma, and which is an unplatted tract described as follows, to wit:
A tract of land lying in the NE/4 of the NW/4 of Section 34, Twp. 5N, Range 22 WIM, described as follows:

Beginning at a point 950 feet South of the NE/Cor. of the NW/4 of said Section 34; Thence West 350 feet; Thence South 295 feet; Thence East 350 feet; Thence North 295 feet to point of beginning, containing 2.5 acres, more less.

Section 2. That the jurisdiction of the City of Mangum, Oklahoma, is hereby extended over and includes all the above-described land for any and all municipal purposes as provided by law.

Section 3. An emergency is hereby declared to exist whereby for the preservation of the public peace, health and safety it is necessary that this Ordinance shall be in full force and effect immediately from and after its passage, approval and publication.
