

ORDINANCE NO. 2002-7-11

AN ORDINANCE ANNEXING REAL PROPERTY LOCATED IN SECTION 17, TOWNSHIP 7 SOUTH, RANGE 2 EAST, LOVE COUNTY, OKLAHOMA, TO THE CITY OF MARIETTA; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MARIETTA:

WHEREAS, James A. and Maxine Reed, the owners of the real property hereinafter described has, by written letter to the City of Marietta, requested that annexation of said real property into the boundaries of the City of Marietta; and

WHEREAS, the City of Marietta agrees to the annexation of said real property into its boundaries; and

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MARIETTA, OKLAHOMA:

That the boundaries of the City of Marietta, Love County, Oklahoma, be and the same are hereby extended so as to include the real property described as follows:

Section 17, Township 7 South, Range 2 East; tract beginning 267.80 feet East of the NW corner of the NW/4 NW/4 SW/4; thence East 442.20 feet; thence South 660 feet; thence West 213 feet; thence North 118 feet; thence West 447 feet; thence North 342 feet; thence East 217.80 feet; thence North 200 feet to the point of beginning, containing 7.79 acres.

BE IT FURTHER ORDAINED that the above-described real property, while being annexed into the boundaries of the City of Marietta, shall be zoned R-2.


