

ORDINANCE NO. 2006-6-7

AN ORDINANCE ANNEXING REAL PROPERTY LOCATED IN SECTION 18, TOWNSHIP 7 SOUTH, RANGE 2 EAST, LOVE COUNTY, OKLAHOMA, TO THE CITY OF MARIETTA; AND DECLARING AN EMERGENCY.

WHEREAS, Betty A. Freeman a/k/a Betty Ann Anderson and Ted Freeman, husband of Betty A. Freeman, owners of the real property hereinafter described have, by written letter to the City of Marietta, requested the annexation of said real property into the boundaries of the City of Marietta; and

WHEREAS, the City of Marietta agrees to the annexation of said real property into its boundaries;

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF MARIETTA, OKLAHOMA:

1. The boundaries of the City of Marietta, Love County, Oklahoma, be and the same are hereby extended so as to include the real property described as follows:

A tract of land located in the E/2 of the W/2 of Section 18, Township 7 South, Range 2 East, Love County, Oklahoma and more particularly described as follows: Beginning at the Northeast Corner of the NW 1/4 of the SW 1/4 of Section 18, Township 7 South, Range 2 East, Love County, Oklahoma; thence N00°00'00"E 660.24 feet; thence N89°53'14"E 1158.29 feet to a point on the West right-of-way of Federal Highway I-35; thence S0°29'37"W 1492.63 feet along said right-of-way; thence S03°13'53"W 977.85 feet along said Federal Highway I-35 right-of-way; thence S14°06'52"W 238.09 feet along said right-of-way; thence S25°58'28"W 228.67 feet along said Federal Highway I-35 right-of-way; thence S89°56'W 606.40 feet; thence S00°00'00"W 269.00 feet; thence S79°37'18"W 331.12 feet; thence N00°00'00"E 2572.45 feet to the point of beginning, containing 76.20 acres more or less.

2. The above-described real property, while being annexed into the boundaries of the City of Marietta, shall be zoned R-1.

3. It being immediately necessary for the preservation of the peace, health, safety and public good of the City of Marietta and the inhabitants thereof, that the provisions of this Ordinance be put into full force and effect, an emergency is hereby declared to exist by reason whereof this Ordinance shall take effect and be in full force from and after the date provided herein as provided by law.
