AN ORDINANCE DE-ANNEXING THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 12 NORTH, RANGE 4 EAST OF THE INDIAN MERIDIAN, LINCOLN COUNTY, OKLAHOMA FROM THE TOWN LIMITS OF THE TOWN OF MEEKER, OKLAHOMA; DIRECTING THE FILING OF A CERTIFIED COPY OF THIS ORDINANCE WITH MAP OR PLAT ATTACHED; REPEALING ALL ORDINANCES AND REGULATIONS IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY IN CONNECTION HEREWITH.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MEEKER, OKLAHOMA:

Section 1: That the following described property, which is currently located within the town limits of the Town of Meeker, Oklahoma, be, and is hereby de-annexed and detached from the town limits of Meeker, Oklahoma:

The Northwest Quarter of Section 29, Township 12 North, Range 4 East of the Indian Meridian, Lincoln County, Oklahoma.

Section 2: That the chairman shall cause to be filed and recorded a duly certified copy of this ordinance together with an accurate map or plat of the territory de-annexed in the Office of the County Clerk, Lincoln County, Oklahoma, and with the Ad Valorem division of the Oklahoma Tax Commission.

Section 3: That all ordinances and zoning regulations in conflict herewith are hereby repealed.


Section 4: WHEREAS, it being necessary for the preservation of the peace, health and safety of
