ORDINANCE # 277

AN ORDINANCE ANNEXING A TERRITORY ADJACENT TO THE TOWN OF MOORELAND WHICH HAS NOT BEEN PLATTED OR RECORDED


BE IT ORDAINED by the Council of the Town of Mooreland, Oklahoma that:

1. An application was submitted by the Mooreland Public Schools for annexation of a territory adjacent to the Town of Mooreland which has not been platted and recorded. The property to be annexed is a tract of land situated in the W/2 NW/4 of Section 26, T 23 N, R 19 W.I.M. Woodward County, Oklahoma, more particularly described as follows: beginning at a point a distance of 571.75 feet East (N89°52'55"E) on the section line and 1517.95 feet South (S00°14'21"W) of the Northwest corner of said Section 26, thence continuing South (S00°14'21"W) a distance of 520.69 feet; thence East (N89°52'58"E) a distance of 394.07 feet; thence North (N00°28'32"E) a distance of 520.71 feet; thence West (S89°52'55"W) a distance of 396.22 feet to the point of beginning, said tract containing 4.7232 acres. Pursuant to Title 11 Oklahoma Statutes section 21-104, the Town of Mooreland prepared a plan to extend appropriate town services, including , but not limited to, water, sewer, fire protection, law enforcement and the cost of such services to the proposed annexed territory and caused notice of a public hearing to be published in a legal newspaper of general circulation in the territory sought to be annexed. Said notice by publication was published within fourteen (14) days following the date the town board of trustees directed the notice to be published. Public hearing was held no earlier than fourteen (14) days nor later than thirty (30) days following the publication and mailing of notice by first-class mail to all owners of property to be annexed. The notice stated the date, time and place the town board of trustees were to conduct the public hearing on the question of annexing the territory.
2. That notice by publication was proper as such was published in the Mooreland Leader on the 6th day of October, 2005 and notice mailed to Mooreland Public Schools the only property owner within the territory to be annexed.
3. That public hearing was held this 14th day of Nov, 2005 at 6:30 p.m. and no objection to said annexation of said territory was heard. That at said hearing the service plan for annexation was available for inspection and explanation.

THEREFORE it is hereby ordained that the above described territory is annexed to the limits of the Town of Mooreland and such territory shall receive the benefits and services thereof and likewise be subject to the laws and ordinances of the Town of Mooreland.


