

ORDINANCE No. 549,

AN ORDINANCE ANNEXING A PART OF LEECH ADDITION OF THE TOWN OF MOUNTAIN VIEW, KIOWA COUNTY, STATE OF OKLAHOMA, TO THE TOWN OF MOUNTAIN VIEW, KIOWA COUNTY, STATE OF OKLAHOMA.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE TOWN OF MOUNTAIN VIEW, KIOWA COUNTY, STATE OF OKLAHOMA.

Section 1.

That heretofore petitions having been filed with the Clerk of said Town of Mountain View, by the people residing and living and owning property in Blocks 8, 9, 10, 11, 12, 16, 17, 18, 19, 20, and 21, of Leech Addition to the Town of Mountain View, Kiowa County, Oklahoma, requesting the annexation of all of the aforesaid blocks in the aforesaid addition to the Town of Mountain View, Kiowa County, Oklahoma, and notice of the presentation of such petition having been duly given by publication for two weeks in the Mountain View News, a legal publication within said Town of Mountain View, in the issues of June 15 and June 22nd, respectively, 1961, of said paper, and

Section 2.

Thereupon the Board of Trustees of said Town duly considered and examined the petition filed by the owners of said property in Leech Addition to such town, desiring to become annexed, and which is a continuous tract and adjacent to said Town, requesting annexation, and from such petition finds that each of said petitioners so signing said petition were legal voters and that such petition was signed by three fourths of the legal voters and by the owners of not less than three fourths in value of the property in the territory so petitioned to be annexed, and that said petition should be allowed, and that the said territory should be annexed to the Town of Mountain View, Kiowa County, Oklahoma, and that the said petition and the notice of the filing of such petition are regular and does in all things comply with the law relating to annexation of property on petition of three-fourths of the voters and property owners in such territory desired to be annexed, and also represents more than three fourths in value of the property situated within such territory, and such Board of Trustees, finds that the said petition for annexation should be allowed as to all of the above described blocks in such addition.

Section 3.

Therefore, it is hereby ordered that the City Limits of the Town of Mountain View, Kiowa County, Oklahoma, shall constitute and be extended to include within the limits of said Town, the following property, viz:

All of Blocks 8, 9, 10, 11, 12, 16, 17, 18, 19, 20 and 21, of Leech Addition to the Town of Mountain View, according to the recorded plat thereof, and being situated in Kiowa County, Oklahoma.

Section 4.

That this ordinance shall be in force and take effect from and after its passage, approval and publication as required by law, and whereas an immediate necessity exists, therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this ordinance shall be in full force and effect from and after its passage, publication and approval as first above stated.
