

ORDINANCE No. 552

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED LAND TO THE TOWN OF MOUNTAIN VIEW, KIOWA COUNTY, STATE OF OKLAHOMA

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MOUNTAIN VIEW, KIOWA COUNTY, STATE OF OKLAHOMA,

Section 1.

That heretofore petition having been filed with the Clerk of said Town, signed by the sole owner of the property petitioned to be annexed, requesting the annexation of the hereinafter described property to the Town of Mountain View, and notice of presentment of such petition having been duly given by publication for two successive weeks in the Mountain View News, a legal publication within said Town of Mountain View, Kiowa County, Oklahoma, in the issue of February 22nd, 1973 and the ~~sixth~~ 1st day of March 1973, of said paper, and

Section 2.

Thereupon the Board of Trustees of said Town duly considered and examined the petition filed by the owner of said property, all of which is adjacent to the Town of Mountain View, Oklahoma, and it being contiguous tract so being requested to be annexed, and from such petition finds that it was signed by the sole owner of such tract, desiring annexation, and that the said petition should therefore be allowed, and that the said petition and the notice of the filing of such petition are regular and does in all things comply with the law regulating annexation of property as provided by Title 11, O. S. A. Sec 482 and 484, as amended.

Section 3.

Therefore it is hereby ordered that the City limits of the Town of Mountain View, Kiowa County, Oklahoma, shall be extended to include within the limits of said Town, the following described property, viz: Block One (1), containing lots 1 to 24 inclusive, Block Two (2), containing Lots 1 to 26 inclusive, Block 3, containing Lots 1 to 26 inclusive, Block 4, containing Lots 1 to 26 inclusive, Block 5, containing Lots 1 to 26 inclusive, Block 6, containing Lots 1 to 13 inclusive, of West View Subdivision to Mountain View, Kiowa County, State of Oklahoma, and the same being platted out of the South Half of the South Half of Section 2, Township 7 North, Range 15, W. I. M. Kiowa County, Oklahoma.

That this ordinance shall be in force and take effect from and after its passage, approval and publication as required by law, and WHEREAS, an immediate necessity exists, therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof, this ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
