

ORDINANCE NO. 03-14-08-1

AN ORDINANCE PROVIDING FOR THE ANNEXATION
TO THE TOWN OF MULDROW, OKLAHOMA
CERTAIN PROPERTY HEREINAFTER SET OUT

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MULDROW,
OKLAHOMA.

SECTION 1.

That Notice is hereby given that at least three-fourths (3/4) of the registered voters and the owners of at least three-fourths (3/4) in value of the following described property adjacent to the Town of Muldrow have requested annexation by signing and filing a petition with the Board of Trustees of the Town of Muldrow, to-wit:


