ORDINANCE NO. 3445-A

AN ORDINANCE ANNEXING TERRITORY ADJACENT TO THE CITY LIMITS UPON PETITION OF THE OWNERS, SAID TERRITORY BEING DESCRIBED AS FOLLOWS: ALL OF BLOCKS 1 AND 2 IN CLEARVIEW ACRES ADDITION TO THE CITY OF MUSKOGEE, MUSKOGEE COUNTY, STATE OF OKLAHOMA, CONTAINING APPROXIMATELY 5.05 ACRES, MORE OF LESS LOCATED AT THE NORTHWEST CORNER OF SOUTH 24TH STREET AND HANCOCK; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY (Willa Davis, Clifford Blevins, Alfonso Thornton, John Ruben and Patricia Conley, Petitioners).

WHEREAS, the owners of at least a majority of the acres described in Section 1 of this Ordinance, said land being contiguous to and adjacent to the City of Muskogee, have requested in writing that the same be annexed to and added to the City;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSKOGEE, OKLAHOMA, THAT:

Section 1: The area by which the petition seeks annexation is described as follows:

ALL OF BLOCKS 1 AND 2 IN CLEARVIEW ACRES ADDITION TO THE CITY OF MUSKOGEE, MUSKOGEE COUNTY, STATE OF OKLAHOMA, CONTAINING APPROXIMATELY 5.05 ACRES, MORE OF LESS LOCATED AT THE NORTHWEST CORNER OF SOUTH 24TH STREET AND HANCOCK.


Section 2: The increase of the City by the annexation of the hereinbefore described property will redound to the benefit of the City and the same is hereby annexed.

Section 3: A copy of the Ordinance, together with an accurate map of the territory annexed, certified by the Mayor and the City Clerk, shall be filed in the office of the County Clerk of Muskogee County, Oklahoma.

Section 4: SEVERABILITY. Should any section, subsection, sentence, provision, clause, or phrase hereof be held invalid, void, or unconstitutional for any reason, such holding shall not render invalid, void, or unconstitutional any other section, subsection, sentence, provision, clause, or phrase of this Ordinance, and the same are deemed severable for this purpose.

Section 5: EMERGENCY. This Ordinance being designated to protect the health and safety of the inhabitants of the City of Muskogee, Oklahoma, an emergency is hereby declared to exist whereby the same shall be in full force and effect from and after its adoption and publication.
