AN ORDINANCE ANNEXING TERRITORY WHERE ALL SIDES OF SAID TERRITORY TO BE ANNEXED ARE ADJACENT OR CONTIGUOUS TO PROPERTY ALREADY WITHIN THE MUNICIPAL LIMITS, ALL SAID TERRITORY BEING GENERALLY DESCRIBED AS ALL OF SECTION 3, TOWNSHIP 14 NORTH, RANGE 18 EAST; W/2 OF THE SW/4 & NW/4 OF SECTION 2, TOWNSHIP 14 NORTH, RANGE 18 EAST; ALL OF SECTION 34, TOWNSHIP 15 NORTH, RANGE 18 EAST; E/2 OF THE E/2 OF SECTION 33, TOWNSHIP 15 NORTH, RANGE 18 EAST; S/2 OF THE SW/4 OF SECTION 35, TOWNSHIP 15 NORTH, RANGE 18 EAST; MUSKOGEE COUNTY OKLAHOMA; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

WHEREAS, all sides of the territory to be annexed as described in Section 1 of this ordinance are contiguous to and adjacent to the property already within the city limits of the City of Muskogee; and

WHEREAS, the notice of proposed annexation has been duly given and published in a legally qualified newspaper of general circulation in the territory to be annexed; and

WHEREAS, a proposed service plan has been available for inspection and was presented for public hearing; and

WHEREAS, the Service Plan provides for municipal services appropriate to the area with implementation occurring within a reasonable time as set forth in the Service Plan.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSKOGEE, OKLAHOMA, THAT

Section 1: The area or territory to be annexed is generally described as follows:

- All of Section 3, Township 14 North, Range 18 East
- W/2 of the SW/4 & NW/4 of Section 2, Township 14 North, Range 18 East
- All of Section 34, Township 15 North, Range 18 East
- E/2 of the E/2 of Section 33, Township 15 North, Range 18 East
- S/2 of the SW/4 of Section 35, Township 15 North, Range 18 East
- All within Muskogee County, State of Oklahoma.

Section 2: The Service Plan is attached hereto, made a part hereof and marked as Exhibit "A". The implementation of said plan shall be completed within ten (10) years.

Section 3: The increase of the City by the annexation of the hereinbefore described property will redound to the benefit of the City and the same is hereby annexed.

Should any section, subsection, sentence, provision, clause, or phrase hereof be held invalid, void, or unconstitutional for any reason, such holding shall not render invalid, void, or unconstitutional any other section, subsection, sentence, provision, clause, or phrase of this Ordinance, and the same are deemed severable for this purpose.

Section 6: EMERGENCY. This Ordinance being designated to protect the health and safety of the inhabitants of the City of Muskogee, Oklahoma, an emergency is hereby




