

ORDINANCE NO. 3679-A

AN ORDINANCE ANNEXING TERRITORY THAT ABUTS THE CITY LIMITS ON THREE SIDES, SAID TERRITORY BEING GENERALLY DESCRIBED AS ALL OF SECTION 1, TOWNSHIP 14 NORTH, RANGE 18 EAST; N/2 OF THE NE/4 OF SECTION 2, TOWNSHIP 14 NORTH, RANGE 18 EAST; ALL OF SECTION 12, TOWNSHIP 14 NORTH, RANGE 18 EAST; N/2 OF THE NE/4 OF SECTION 11, TOWNSHIP 14 NORTH, RANGE 18 EAST; ALL WITHIN MUSKOGEE COUNTY, STATE OF OKLAHOMA; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY (City of Muskogee, Petitioners)

WHEREAS, the territory described in Section 1 of this ordinance is contiguous to and adjacent to the City of Muskogee on three sides;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSKOGEE, OKLAHOMA, THAT

Section 1: The area which the petition seeks annexation is generally described as follows:

All of Section 1, Township 14 North, Range 18 East
N/2 of the NE/4 of Section 2, Township 14 North, Range 18 East
All of Section 12, Township 14 North, Range 18 East
N/2 of the NE/4 of Section 11, Township 14 North, Range 18 East
All within Muskogee County, State of Oklahoma.


Section 2: The increase of the City by the annexation of the hereinbefore described property will redound to the benefit of the City and the same is hereby annexed.

Section 3: A copy of the Ordinance, together with an accurate map of the territory annexed, a copy of which is attached, certified by the Mayor and the City Clerk, shall be filed in the office of the County Clerk of Muskogee County, Oklahoma.

Section 4: SEVERABILITY. Should any section, subsection, sentence, provision, clause, or phrase hereof be held invalid, void, or unconstitutional for any reason, such holding shall not render invalid, void, or unconstitutional any other section, subsection, sentence, provision, clause, or phrase of this Ordinance, and the same are deemed severable for this purpose.

Section 5: EMERGENCY. This Ordinance being designated to protect the health and safety of the inhabitants of the City of Muskogee, Oklahoma, an emergency is hereby declared to exist whereby the same shall be in full force and effect from and after its adoption and publication.


