

ORDINANCE NO. 3890-A

AN ORDINANCE MODIFYING THE CORPORATE BOUNDARIES OF THE CITY OF MUSKOGEE BY DE-ANNEXING THERE FROM, LOTS 1 THRU 6 IN BLOCK 2, LOTS 15 & 16 LESS NORTH 50 & ALL OF LOTS 17 THRU 20 IN BLOCK 1, JUDSON C FAST COUNTY ADDITION, AND T15N R19E S19 FARMLAND IN MUSKOGEE LOT 1 N FRISCO RIGHT OF WAY LESS 1.19 ACRES RIGHT OF WAY, AND T15N R19E S19 FARMLAND IN MUSKOGEE PART NW BEGINNING NW/C NE NW S TO RAILROAD RIGHT OF WAY ALONG RIGHT OF WAY TO POINT 1020.32 W E LINE NE NW NWRLY 214 W36 N278 W6527.6 NERLY TO N LINE SECTION 19 TO POINT 1110.3 W NE/C NE NW W TO POINT OF BEGINNING LESS ROAD, AND T15N R18E S19 FARMLAND IN MUSKOGEE NRLY 1.36 AC LY S & W RR R/W LOT 1, CONTAINING 29.57 ACRES, MORE OR LESS; AND DECLARING AN EMERGENCY.

WHEREAS, that area of land as hereafter described, located within the corporate limits of the City of Muskogee, Oklahoma, should be removed and excluded from the corporate limits of the City of Muskogee.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSKOGEE, OKLAHOMA, THAT:

Section 1: That area of land hereby removed and excluded from the corporate limits of the City of Muskogee is described as follows:

LOTS 1 THRU 6 IN BLOCK 2, LOTS 15 & 16 LESS NORTH 50 & ALL OF LOTS 17 THRU 20 IN BLOCK 1, JUDSON C FAST COUNTY ADDITION, AND T15N R19E S19 FARMLAND IN MUSKOGEE LOT 1 N FRISCO RIGHT OF WAY LESS 1.19 ACRES RIGHT OF WAY, AND T15N R19E S19 FARMLAND IN MUSKOGEE PART NW BEGINNING NW/C NE NW S TO RAILROAD RIGHT OF WAY ALONG RIGHT OF WAY TO POINT 1020.32 W E LINE NE NW NWRLY 214 W36 N278 W6527.6 NERLY TO N LINE SECTION 19 TO POINT 1110.3 W NE/C NE NW W TO POINT OF BEGINNING LESS ROAD, AND T15N R18E S19 FARMLAND IN MUSKOGEE NRLY 1.36 AC LY S & W RR R/W LOT 1, CONTAINING 29.57 ACRES, MORE OR LESS.

Section 2: All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

Section 3: A copy of the Ordinance, together with an accurate map of the territory so removed and excluded from the corporate limits of the City of Muskogee, certified by the Mayor and the City Clerk, shall be filed in the office of the County Clerk of Muskogee County, Oklahoma.



Section 4: SEVERABILITY. Should any section, subsection, sentence, provision, clause, or phrase hereof be held invalid, void, or unconstitutional for any reason, such holding shall not render invalid, void, or unconstitutional any other section, subsection, sentence, provision, clause, or phrase of this Ordinance, and the same are deemed severable for this purpose.

Section 5: EMERGENCY. This Ordinance being designated to protect the health and safety of the inhabitants of the City of Muskogee, Oklahoma, an emergency is hereby declared to exist whereby the same shall be in full force and effect from and after its adoption and publication.


