

ORDINANCE NO. 2004- 3

AN ORDINANCE ANNEXING UPON PETITION OF THE LANDOWNER CERTAIN PROPERTY WITHIN THE MUNICIPAL LIMITS OF NEWKIRK, OKLAHOMA AND EXTENDING THE MUNICIPAL LIMITS.

BE IT ORDAINED BY THE CITY COMMISSIONERS OF THE CITY OF NEWKIRK, OKLAHOMA:

SECTION 1: By a written petition, the owner of the following described land, to wit:

A tract of land in the Northeast Quarter of Section 27, Township 28 North, Range 2 East of the Indian Meridian, Kay County, State of Oklahoma. More particularly described as follows:

Commencing at the Southeast corner of said NE/4; thence N 0°20'07" E for a distance of 657.73 feet in the Northeast corner of the S/2 of the SE/4 of said NE/4; thence N 89°42'04" W along the North line of the S/2 of the SE/4 of said NE/4 for a distance of 133.80 feet to the true point of beginning; thence S 0°10'43" W along a Highway right-of-way-line for a distance of 230.00 feet; thence N 89°42'04" W for a distance of 570.00 feet; thence N 0°10'43" E for a distance of 230.00 feet; thence S 89°42'04" E for a distance of 570.00 feet to the true point of beginning.

seeks to have the said property annexed into the City of Newkirk. The said land is contiguous with the municipal limits of the City of Newkirk except for an intervening highway right of way.

SECTION 2: The addition of said territory shall redound to the benefit of the City of Newkirk. The property owner therein shall be entitled to the same rights and privileges and subject to the same duties and obligations as any other property owner within the City.

SECTION 3: The municipal limits of the City of Newkirk, Oklahoma, are hereby extended to include:


